C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: According to the APT, which used data available from GA Weather Stations within proximity of the review area the site conditions at the time of the delineation performed on July 18, 2018, were wetter than normal. These data are based on a projected 30-day rolling average of precipitation documented within the 30th and 70th percentile of the 30-year record for average precipitation. Therefore, there is a high level of confidence that excluded features are not jurisdictional. Based on review of historic aerial imagery, the adjacent warehouse building and truck parking pad were constructed between 1980 and 1988. As a component of this facility, the existing stormwater management basin was installed to service the development. Review of both historic topographic maps, as well as the aerial topographic layer available through the Fulton County Property Viewer, indicate that the site of the subject water does not correspond to a natural topographic depression or drainageway. The site is not associated with the USGS National Hydrography Dataset, NRCS mapped hydric soils, or an NWI mapped wetland polygon and does not currently meet the definition of a water of the United States. As a result, it appears that the site is more accurately characterized as being composed entirely of upland prior to the establishment of a facility designed to convey, treat, infiltrate, or store stormwater run-off. In addition, per 33 CFR 328.3, the subject feature also meets the intent of a waste treatment system, designed to meet the allied requirements of Clean Water Act, which are by definition not waters of the United States.
