C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

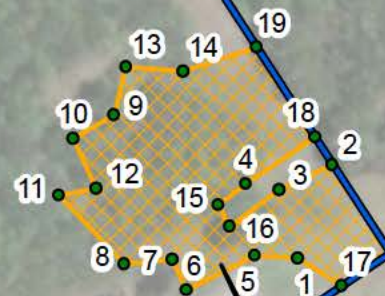
B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland 1 (0.44-acres) is a depressional non-jurisdictional wetland located at 32.180182, -81.463491. The wetland is +/-2,500 linear feet from the nearest potentially jurisdictional water, approximately 8.3 miles from the nearest TNW (Ogeechee River) and +/-650 linear feet from the 100 year flood plain. The uplands surrounding the wetland are approximately 0.5-2 foot higher in elevation than the average surface elevation within the wetland. During the site inspection no direct surface connection

was found between this wetland and other waters. Further there is no evidence of surface-water flow to or from the feature. The upland soils located between the non-jurisdictional wetland and the nearest potentially jurisdictional wetland are mapped as Mascotte (PD). Based on observed site conditions and soil permeability, it appears that any subsurface flow would occur from the upland into the wetland.

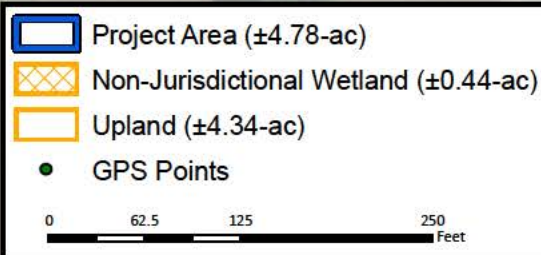
