Explain: Virtual mapping reveals that the feature is not visible on mapping until the adjacent roads (Beaver Drive and Hamilton Crossing Road NW) were constructed in uplands. The area around the feature is maintained as a grassed roadway right-of-way (ROW). The feature does not display the physical characteristics of an OHWM, per Regulatory

Guidance Letter (RGL) 05-05. Rather, the feature is U-shaped along the bottom, indicative of an excavated man-made ditch. Further, the site was previously used for agricultural production from 1955 - 1981, and the adjacent land is clear of large woody vegetation and has been since at least 1955. The feature is slightly lined with trees along what appears to be the property boundary and is not typical of riparian areas maintained along agricultural fields due to the very limited width of the feature. The feature may have been used as an agricultural ditch during this period of agricultural production. The roadways were constructed between 1981 - 1993, per review of historic aerial imagery. Therefore, the feature is best characterized as a preambled water; drainage ditch created during the construction of the existing roadways.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
