Other: (explain, if not covered above): The review a area includes a wetland (1.6-acres), referred to as Wetland 1, that meets the criteria in the 1987 Corps of Engineers Wetland Delineation Manual and/ or appropriate Regional Supplements. However, the wetland does not meet the criteria for bordering, contiguous, or neighboring. Wetland 1 is approximately 860 linear feet (straight-line distance) from the nearest presumed jurisdicational water. The wetland area does not meet the criteria for bordering, contiguous or neighboring. Therefore, the wetland is considered an isolated feature.

There is a roadside ditch (844 linear feet) located along Grogan Road. The ditch does not have the physical characteristics of an Ordinary High Water Mark (OHWM), per Regulatory Guidance Letter (RGL) 05-05. The road was constructed prior to 1945, no solid or dashed blue line features are depicted on mapping. The feature appears to have formed after the road was constructed to allow stormwater to sheetflow off of the roadway and over time formed a roadside ditch. Therefore, the ditch is considered a preamble water.

Further, the project site has been in agricultural production or used as pasture for livestock from 1945-2021. Areas adjacent to both features were previously cleared of vegeation and used for agriculture, per review of historic aerial imagery. Drainage features, typical of agricultural land-use, are visible on historic aerial imagery, as early as 1955, suggesting that construction of the roadway and cleared areas for agriculture have affected the path of water over time.

Other: (explain, if not covered above): There are three preamble agricultural ditches that were identified within the review area. These features are referred to as Ditch Eastern (1442 linear feet), located centrally within the review area from north to south, Spur 1, located in the southern portion of the site, and Spur 2, located centrally from west to east. Review of topographic mapping shows that there was a solid blue line stream located in the alignment of the agricultural ditches in 1944-1964. However, the blue line feature appears to have been relocated to the south of the review area, between 1964-1974. Review of historic aerials shows that the area was cleared of vegetation for agriculture between 1944-2021 and drainage patterns typical of agricultural usage are visible on aerial imagery. These features do not display the physical characteristics of an OHWM, per RGL 05-05. Further, the area is not typical of a stream channel and there are only a few trees growing ajacent to the drainage fetures in the year 2000, more typical of property line boundaries and not of riparian areas. Review of site photographs reveals a wet area without a clearly defined channel with hoof prints from livestock (cattle). These areas appear to be trodded cattle routes within agricultural pasture, and therefore are consider preamble waters.

The review area includes three (3) wetland areas that meet the criteria in the 1987 Corps of Engineers Wetland Delineation Manual and/ or appropriate Regional Supplements. These features are referred to as Wetland 7 (2.17-acres), Wetland 8 (0.12-acres), and Wetland 9 (0.24-acres). Wetland 7 is located in the northeast portions of the review area, Wetland 8 is located in the northwest corner of the review area, while Wetland 9 is located in the central portions of the review area. Wetland 8 is located nearest to presumed jurisidctional waters, approximately 275 linear feet (straight-line distance). However, these three wetland areas do not meet the criteria for contiguous, abutting, or neighboring. Therefore, these wetlands are considered isolated features.
