C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland 1 (W1) was the sole aquatic resource identified in the review area during a field survey, conducted by Corblu Ecology Group, LLC, on October 27, 2021. Wetland 1 (W1) was a forested depressional wetland located in the central portion of the review area and was approximately 0.226-acres in size. W1 was a depressional feature situated in the central portion of a draw running through the middle of the review area. Overland flows after rain events flowed into W1 from the surrounding slopes and appeared to be held in this wetland until it infiltrated or flowed downslope. W1 contained overstory and mid-story vegetation which included, but was not limited to, sweetgum (*Liquidambar styraciflua*), water oak (*Quercus nigra*), black gum (*Nyssa sylvatica*), red maple (*Acer rubrum*), and American holly (*Ilex opaca*). Understory vegetation included American holly and Chinese privet (*Ligustrum sinense*). Wetland indicators present included saturation within 12 inches of the surface, oxidized root channels, water-stained leaves, and drainage patterns. Hydric soil indicators were observed and included low-chroma soil colors of 10YR 4/2 and 10YR 3/2 with redoximorphic features. Hydric soil indicators F3-Depleted Matrix and F6-Redox Dark Surface were met. No distinct line of wretched vegetation was observed within W1.

No stream or wetland features were observed upslope or downslope of W1. Five separate datapoints were taken above and below the wetland to characterize these areas. No hydric soils or indicators of hydrology were observed at any of these datapoints. Wetland dataforms are included for each of the datapoints that were assessed.

The USACE Antecedent Rainfall Tool was used to determine the existing conditions at the time of the delineation. The antecedent rainfall tool determined that the conditions at the time of the delineation was during a period that was "wetter than normal", based on comparisons of rainfall from the previous three months to the 30-year normal rainfall range.
