B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE

REVIEW AREA ONLY INCLUDES DRY LAND: The preponderance of evidence indicates that this parcel is comprised of only dry land. A stormwater swale is located on part of the site. The erosional swale has been created from the outflow from a pipe draining stormwater from the street (Stratford Arms Drive) and extending under the driveway of 2625 Mural Drive, Chamblee, GA.
