C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetland E is a 2.65-acre isolated wetland. Said wetland is not located within the mapped 100-year floodplain. The wetland is located approximately 1,200 feet from the nearest jurisdiction water, and approximately 1.2 miles from the nearest TNW. During the inspection of

this site, no surface connection (i.e., ditch, swale, etc.) was found between the wetland and other jurisdictional waters. The landscape surrounding the wetland is approximately 1-3 feet higher in elevation than the surface elevation of the isolated wetland. The soils located between the isolated wetland and the nearest jurisdictional wetland are mapped as Stilson Loamy Sand, which have a sandy texture and are considered permeable. Even though the upland soils are permeable, a shallow subsurface connection cannot be documented due to the distance from the isolated wetland to the nearest jurisdictional water.

Wetland F is a 1.88-acre isolated wetland. Said wetland is not located within the mapped 100-year floodplain. The wetland is located approximately 1,555 feet from the nearest jurisdiction water, and approximately 1.12 miles from the nearest TNW. During the inspection of this site, no surface connection (i.e., ditch, swale, etc.) was found between the wetland and other jurisdictional waters. The landscape surrounding the wetland is approximately 1-3 feet higher in elevation than the surface elevation of the isolated wetland. The soils located between the isolated wetland and the nearest jurisdictional wetland are mapped as Stilson Loamy Sand, which have a sandy texture and are considered permeable. Even though the upland soils are permeable, a shallow subsurface connection cannot be documented due to the distance from the isolated wetland to the nearest jurisdictional water.

Wetland G is a 1.83-acre isolated wetland. Said wetland is not located within the mapped 100-year floodplain. The wetland is located approximately 966 feet from the nearest jurisdiction water, and approximately 1.32 miles from the nearest TNW. During the inspection of this site, no surface connection (i.e., ditch, swale, etc.) was found between the wetland and other jurisdictional waters. The landscape surrounding the wetland is approximately 1-3 feet higher in elevation than the surface elevation of the isolated wetland. The soils located between the isolated wetland and the nearest jurisdictional wetland are mapped as Stilson Loamy Sand, which have a sandy texture and are considered permeable. Even though the upland soils are permeable, a shallow subsurface connection cannot be documented due to the distance from the isolated wetland to the nearest jurisdictional water.

Wetland H is a 1.45-acre isolated wetland. Said wetland is not located within the mapped 100-year floodplain. The wetland is located approximately 1,328 feet from the nearest jurisdiction water, and approximately 1.17 miles from the nearest TNW. During the inspection of this site, no surface connection (i.e., ditch, swale, etc.) was found between the wetland and other jurisdictional waters. The landscape surrounding the wetland is approximately 1-3 feet higher in elevation than the surface elevation of the isolated wetland. The soils located between the isolated wetland and the nearest jurisdictional wetland are mapped as Stilson Loamy Sand, which have a sandy texture and are considered permeable. Even though the upland soils are permeable, a shallow subsurface connection cannot be documented due to the distance from the isolated wetland to the nearest jurisdictional water.

Wetland I is a 1.07-acre isolated wetland. Said wetland is not located within the mapped 100-year floodplain. The wetland is located approximately 358 feet from the nearest jurisdiction water, and approximately 1.12 miles from the nearest TNW. During the inspection of this site, no surface connection (i.e., ditch, swale, etc.) was found between the wetland and other jurisdictional waters. The landscape surrounding the wetland is approximately 1-3 feet higher in elevation than the surface elevation of the isolated wetland. The soils located between the isolated wetland and the nearest jurisdictional wetland are mapped as Dothan Loamy Sand, which have a sandy texture and are considered permeable. Even though the upland soils are permeable, a shallow subsurface connection cannot be documented due to the distance from the isolated wetland to the nearest jurisdictional water.

Wetland J is a 1.01-acre isolated wetland. Said wetland is not located within the mapped 100-year floodplain. The wetland is located approximately 314 feet from the nearest jurisdiction water, and approximately 1.3 miles from the nearest TNW. During the inspection of this site, no surface connection (i.e., ditch, swale, etc.) was found between the wetland and other jurisdictional waters. The landscape surrounding the wetland is approximately 1-3 feet higher in elevation than the surface elevation of the isolated wetland. The soils located between the isolated wetland and the nearest jurisdictional wetland are mapped as Ocilla, which have a sandy texture and are considered permeable. Even though the upland soils are permeable, a shallow subsurface connection cannot be documented due to the distance from the isolated wetland to the nearest jurisdictional water.

Wetland K is a .59-acre isolated wetland. Said wetland is not located within the mapped 100-year floodplain. The wetland is located approximately 909 feet from the nearest jurisdiction water, and approximately 0.97 mile from the nearest TNW. During the inspection of this site, no surface connection (i.e., ditch, swale, etc.) was found between the wetland and other jurisdictional waters. The landscape surrounding the wetland is approximately 1-3 feet higher in elevation than the surface elevation of the isolated wetland. The soils located between the isolated wetland and the nearest jurisdictional wetland are mapped as Dothan Loamy Sand, which have a sandy texture and are considered permeable. Even though the upland soils are permeable, a shallow subsurface connection cannot be documented due to the distance from the isolated wetland to the nearest jurisdictional water.

Wetland L is a 0.37-acre isolated wetland. Said wetland is not located within the mapped 100-year floodplain. The wetland is located approximately 739 feet from the nearest jurisdiction water, and approximately 1.7 miles from the nearest TNW. During the inspection of this site, no surface connection (i.e., ditch, swale, etc.) was found between the wetland and other jurisdictional waters. The landscape surrounding the wetland is approximately 1-3 feet higher in elevation than the surface elevation of the isolated wetland. The soils located between the isolated wetland and the nearest jurisdictional wetland are mapped as Fuquay Loamy Sand, which have a sandy texture and are considered permeable. Even though the upland soils are permeable, a shallow subsurface connection cannot be documented due to the distance from the isolated wetland to the nearest jurisdictional water.

Wetland M is a 0.34-acre isolated wetland. Said wetland is not located within the mapped 100-year floodplain. The wetland is located approximately 382 feet from the nearest jurisdiction water, and approximately 0.98 mile from the nearest TNW. During the inspection of this site, no surface connection (i.e., ditch, swale, etc.) was found between the wetland and other jurisdictional waters. The landscape surrounding the wetland is approximately 1-3 feet higher in elevation than the surface elevation of the isolated wetland. The soils located

between the isolated wetland and the nearest jurisdictional wetland are mapped as Lucy Loamy Sand, which have a sandy texture and are considered permeable. Even though the upland soils are permeable, a shallow subsurface connection cannot be documented due to the distance from the isolated wetland to the nearest jurisdictional water.

Wetland N is a 0.14-acre isolated wetland. Said wetland is not located within the mapped 100-year floodplain. The wetland is located approximately 1,304 feet from the nearest jurisdiction water, and approximately 1.09 miles from the nearest TNW. During the inspection of this site, no surface connection (i.e., ditch, swale, etc.) was found between the wetland and other jurisdictional waters. The landscape surrounding the wetland is approximately 1-3 feet higher in elevation than the surface elevation of the isolated wetland. The soils located between the isolated wetland and the nearest jurisdictional wetland are mapped as Stilson Loamy Sand, which have a sandy texture and are considered permeable. Even though the upland soils are permeable, a shallow subsurface connection cannot be documented due to the distance from the isolated wetland to the nearest jurisdictional water.

Pond 2 is a 1.79-acre upland dug borrow pit. Said borrow pit is not located within the mapped 100-year floodplain. The borrow pit is located approximately 1,521 feet from the nearest jurisdiction water, and approximately 1.26 miles from the nearest TNW. During the inspection of this site, no surface connection (i.e., ditch, swale, etc.) was found between the wetland and other jurisdictional waters. The landscape surrounding the borrow pit is approximately 1-3 feet higher in elevation than the surface elevation of the pit. The soils located between the borrow pit and the nearest jurisdictional wetland are mapped as Stilson Loamy Sand, which have a sandy texture and are considered permeable. Even though the upland soils are permeable, a shallow subsurface connection cannot be documented due to the distance from the isolated wetland to the nearest jurisdictional water.
