Explain: **There are water filled depressions created in dry land incidental to construction activity, which is occurring on an adjacent parcel, located to the east of the review area and an existing trail, located to the north of the review area. The original review area was a railline, which is typically built-up in the center and has sloped riprap on either side, to facilitate train usage. The rails have been removed from the area. Riprap is still evident and the area is still sloped to**

either side of the former railline. There is a culvert, located south of the existing trail, and northeast of the review area. The culvert is located at the base of the residential development, which is being constructed on an elevated tract. The culvert is related to stairs, that were constructed for access from the trail to the adjacent residential development, which contributes water to the lower lying areas within the review area, during and after rain events. The location of the features identified align with the toe-of-slope on both sides of the original railline. These areas were checked for wetland characteristics and according to the wetland delineation manual and the applicable regional supplement the areas do not meet the criteria for any hydric soil indicators.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
