C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Data submitted from the applicant and reviewed during desktop evaluation was used to support this jurisdictional determination. According to the provided documentation and photos taken from applicant during site visit on October 13, 2021, the wetland feature is a depressional, forested wetland that is approximately 0.1 acres in size. Due to its depressional shape, soil characteristics, and topographical characteristic, the wetland feature appears to hold water following rain events and runoff from uphill slopes. According to the information reviewed from the applicant and historical evidence of the site shown from aerial imagery and county data shows the subject property has historically been agricultural in use. The subject wetland is not located within the FEMA FIRM 100-year floodplain.

The Antecedent Precipitation Tool (APT) was used to confirm the site conditions on October 13, 2021 provided. The APT showed that the area was experiencing wetter than normal conditions during the October site visit a (this was supported by the standing water identified in photo 1). The nearest name aquatic feature is Cedar Creek, and is located approximately 500 feet south of the review area, and the nearest TNW to the isolated wetland feature is the Oconee River, which is approximately 30 river miles or 81,000 feet west of the review area.

The soils identified within the review area are mapped as Pacolet clay loam, is considered minimally permeable, and a shallow subsurface connection cannot be documented or established. This was confirmed from the supporting documentation noted in the Web Soil Survey, NHD, and NWI layers retrieved from the National Regulatory Viewer (NRV). Based on the description, the photos, maps, and data reviewed, the path in which water would have to flow from the wetland feature to reach the nearest RPW, Cedar Creek, this feature does not show any surface connection, adjacency, or within proximity to any other aquatic features within the project review area. The path which water must travel from the isolated wetland feature to the Oconee River was assessed and determined to be indirect. Therefore, the wetland feature was not considered to have an adjacent connection to Cedar Creek and was determined to be a geographically isolated.
