C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland A (0.342-acres) is an isolated wetland located at 31.404716, -81.456357. The wetland is +/-1,200 linear feet from the nearest potentially jurisdictional water and approximately 2 miles from the nearest TNW (Butler River). The uplands surrounding the wetland are approximately 1-3 foot higher in elevation than the average surface elevation within the wetland. Further there is no evidence of surface-water flow to or from the feature. The upland soils located between the non-jurisdictional

wetland and the nearest potential jurisdictional wetland are mapped as Klej Fine Sand. Klej Fine Sand is a moderately well drained soil. Based on the agent's wetland data sheets and site report, Wetland A has no sub-surface connection to downstream waters. It appears that any subsurface flow would occur from the upland into the wetland. .

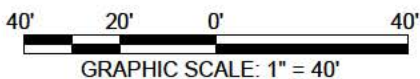

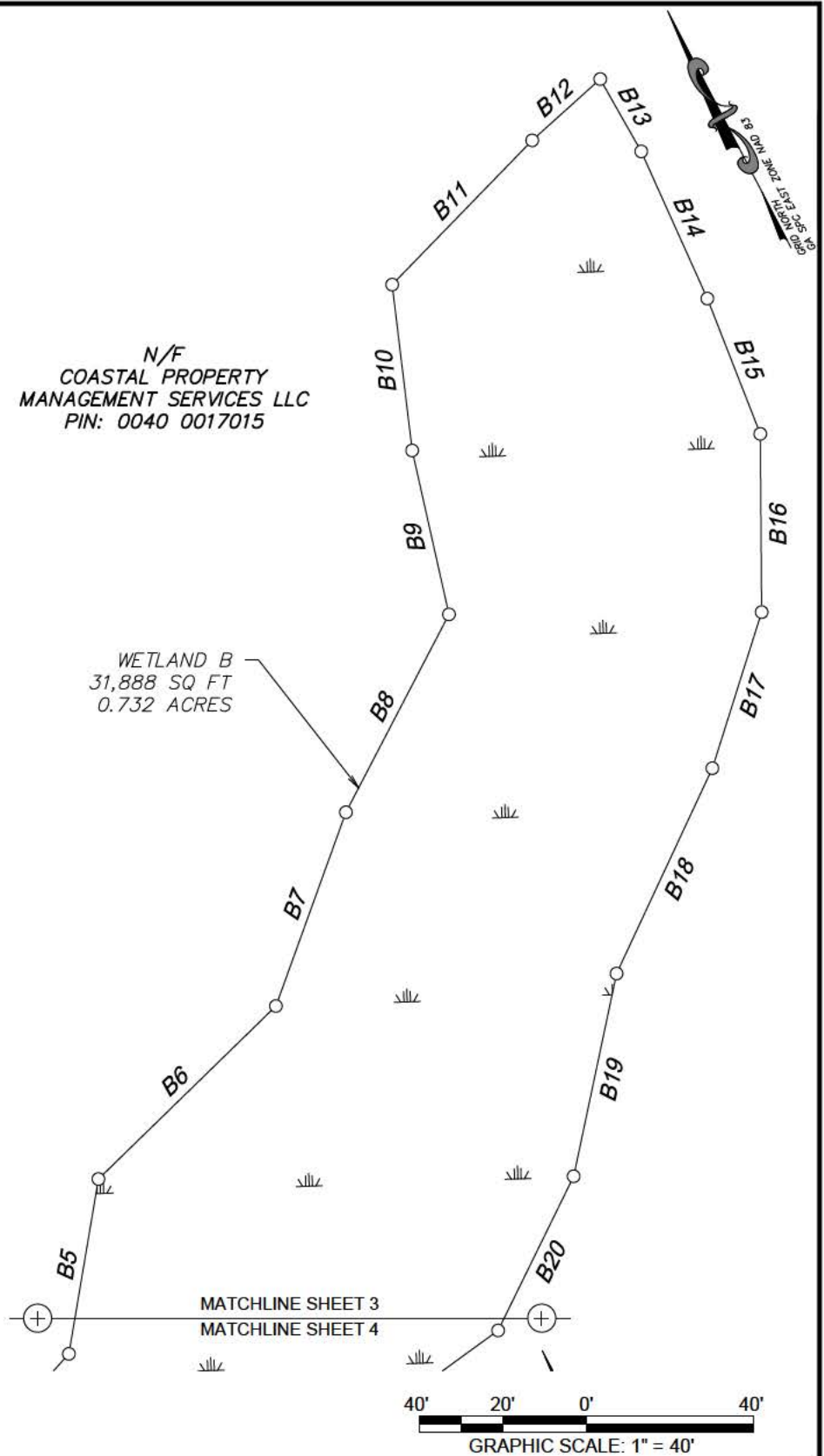

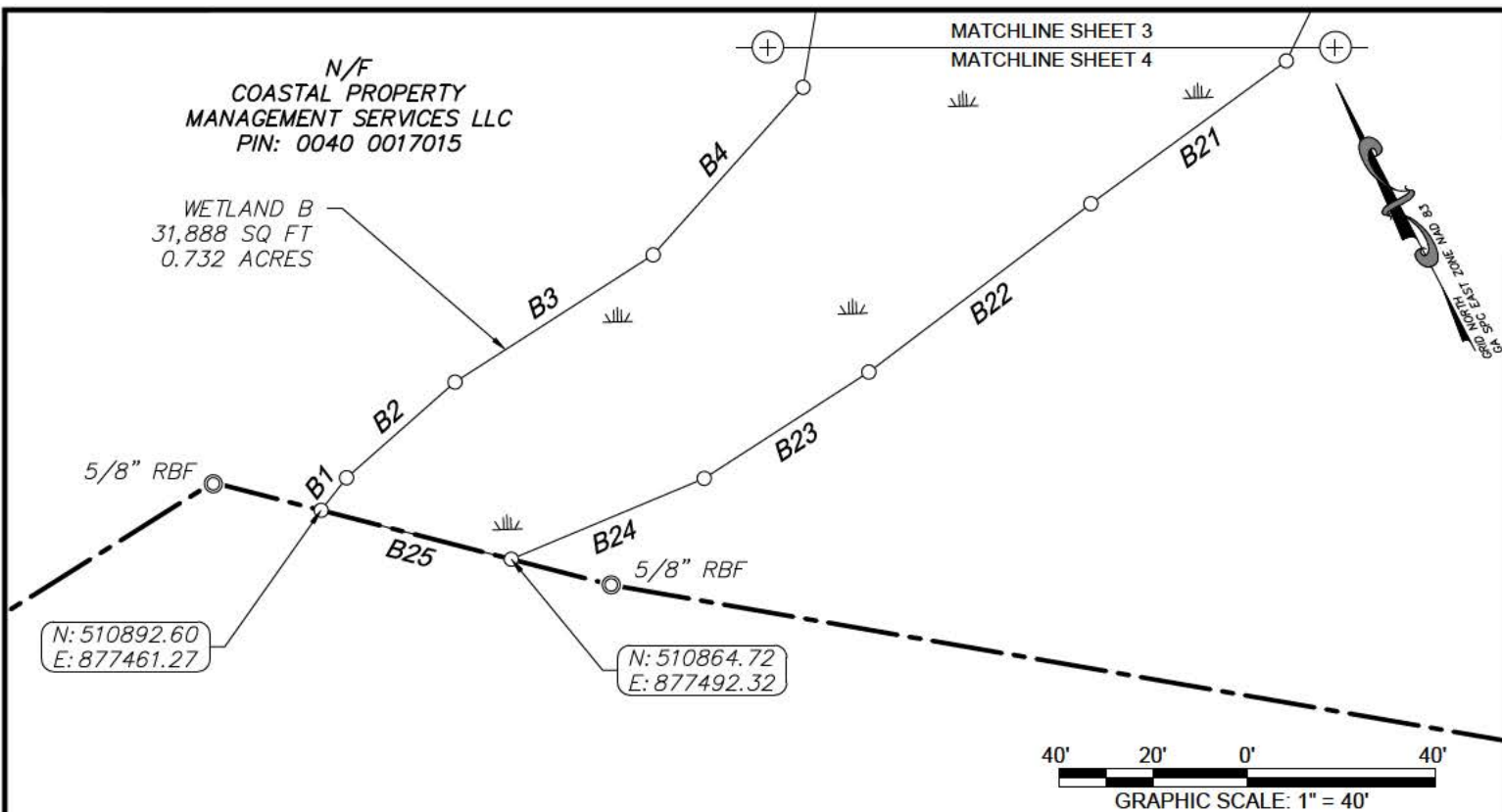
