### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Wetland 1 is approximately 1.68-acres and is located at 31.957186, -81.2255862. The wetland is located approximately 225 feet from the nearest jurisdictional water (wetland 3), 1,095 feet from the nearest TNW (Little Ogeechee River), and 70 feet from the 100-Year Floodplain. During the delineation, no surface connections, such as ditches or swales, were found between this wetland and other jurisdictional waters.

This is a depression bowl, completely surrounded by more highly elevated upland, which would prevent any surface connection to the jurisdictional wetland to the west (wetland 3) or any other wetland. The surrounding soils further support this argument from a subsurface perspective, as the sandy and loamy fine sand texture would allow for percolation downward instead of horizontally to a nearby jurisdictional wetland.

Wetland 2 is approximately 0.21-acres and is located at 31.960769, -81.223551. This wetland is located approximately 820 feet from the nearest jurisdictional water, wetland 5, 115 feet from a stormwater pond to the west, 2000 feet from the nearest TNW (Little Ogeechee River), and 80 feet from the 100-Year Floodplain. During the delineation, no surface connections, such as ditches or swales, were found between this wetland and other jurisdictional waters. As depicted in the LiDAR exhibit, figure 6, this wetland has higher elevations, which provides another geographic barrier, prohibiting surface flow or subsurface flow of water out of the wetland. A trail road is also located between this wetland and the pond to the west. From a subsurface perspective, this wetland is located entirely within an ocilla complex soil that is moderately permeable. This soil type would allow percolation downward instead of horizontally to nearby jurisdictional wetlands or other waters of the U.S...
