C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

It is not physically separated from potentially jurisdictional waters by man-made dikes or barriers, natural river berms, beach dunes, and the like. Isolated Wetland is completely surrounded by uplands with elevations 2 feet higher than the subject water. The subject water is a depression with no outfall containing an Ordinary High Water Mark (OHWM). The closest potentially jurisdictional water to the subject water is a wetland area located outside of the review area, approximately 140 meters southwest of Isolated Wetland. Therefore, the subject water's proximity to a potentially jurisdictional water is not reasonably close. Isolated Wetland is non-abutting and does not meet the description of "adjacent", as defined in 33 CFR 328.3(c). Isolated Wetland is best categorized among Isolated Waters (with no interstate or foreign commerce nexus).**
