C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: CH 500 is geographically isolated. The feature exhibits physical characteristics of an OHWM but terminates abruptly and is not connected to the nearest down-slope water, CH 100. The straight-line distance between CH 500 and CH 100 is approximately 156 linear feet. The area located between CH 500 and CH 100 is flat and does not meet any of the three criteria (hydrology, hydrophytic vegetation and hydric soils) for a wetland per the 1987 delineation manual or the applicable regional supplement. The area between CH 500 and CH 100 also does not provide any direct or indirect connection to downstream waters that would establish a nexus (there are no ditches, culvert pipes, or other features that could direct flow from CH 500 into or toward CH 100, or any other downstream potential waters). The straight-line distance between CH 500 from the nearest TNW is 7.4 miles. CH 500 has one abutting wetland area, WL 5100, that meets the three parameters for a wetland per the 1987 wetland delineation manual and the applicable regional supplement. Two features were identified within the review area within the parcel located north of Bright Star Connector. WL 5200 meets the three parameters for a wetland and drains into EPH 3. EPH 3 exhibits some physical characteristics of a stream, per RGL 05-05. EPH3 does not drain into an existing culvert, and there is no downstream connection to any waters or potential waters located south of Bright Star Road to serve as a connection for EPH 3 or WL 5200. Further, EPH 3 is not connected to CH 500. Additionally, there are four areas that were excavated in dry land located along Bright Star Connector (SCM 1-4). SCM 1-4 are not connected to any other features on the site.
