C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland 1 is approximately 0.832 acres and is located at 32.148121, -81.238429. The wetland is located approximately 990 feet from the nearest jurisdictional water, 4.9 miles from the nearest TNW (Savannah River), and 0.6 miles from the 100-Year Floodplain. Wetland 1 is completely surrounding by uplands that are higher in elevation than the surface elevation of the wetland, as shown in the LiDAR figure.

During the delineation, no surface connections, such as ditches or swales, were found between the wetland and other jurisdictional water. The soils within the wetland are comprised of sands with a drainage class of somewhat poorly drained. This soil is not rated as hydric yet has minimal permeability which would limit subsurface flow from the wetland to other jurisdictional waters. Due to this, the general area would only allow for subsurface flow from uplands to wetland.

Wetland 11 is approximately 0.104 acres and is located at 32.147458, -81.230489. The wetland is located approximately 500 feet from the nearest jurisdictional wetland, 4.5 miles from the nearest TNW (Savannah River), and 0.3 miles from the 100-Year Floodplain. Wetland 11 is completely surrounding by uplands that are higher in elevation than the surface elevation of the wetland, as shown in the LiDAR figure. During the delineation, no surface connections, such as ditches or swales, were found between the wetland and other jurisdictional waters. This wetland is located within a soil types that are considered either poorly drained or somewhat poorly drained, meaning that these soils exhibit minimal permeability which would prevent subsurface flow from the wetland to other jurisdictional waters. Due to this, the general area would only allow for surface and subsurface flow from uplands to wetland.

Wetland 12 is approximately 0.179 acres and is located at 32.147437, -81.230284. The wetland is located approximately 520 feet from the nearest jurisdictional wetland, 4.5 miles from the nearest TNW (Savannah River), and 0.4 miles from the 100-Year Floodplain. Wetland 12 is completely surrounding by uplands that are higher in elevation than the surface elevation of the wetland, as shown in the LiDAR figure. During the delineation, no surface connections, such as ditches or swales, were found between the wetland and other jurisdictional waters. This wetland is located within a soil types that are considered either poorly drained or somewhat poorly drained, meaning that these soils exhibit minimal permeability which would prevent subsurface flow from the wetland to other jurisdictional waters. Due to this, the general area would only allow for surface and subsurface flow from uplands to wetland.

Wetland 13 is approximately 0.322 acres and is located at 32.147977, -81.225590. The wetland is located approximately 2000 feet from the nearest jurisdictional water, 4.2 miles from the nearest TNW (Savannah River), and 0.5 miles from the 100-Year Floodplain. During the delineation, no surface connections, such as ditches or swales, were found between the wetland and other jurisdictional waters. The uplands surrounding Wetland 13 are higher in elevation than the surface elevation of the wetland, as shown in the LiDAR figure. The soils within the wetland is comprised of clay loams with a drainage class of very poorly drained. This soil is rated as hydric and doesn't allow for permeability. However, between this wetland and other jurisdictional wetlands the surrounding soils are comprised of sands meaning surface or subsurface flow from this wetland to other jurisdictional waters is highly unlikely. .
