C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

from the Little River. The subject resource exhibits indicators of all three parameters per the 1987 wetland delineation manual and corresponding regional supplement methodology. The western portion of the delineated polygon is composed of a dominantly forested vegetative community and the eastern portion is primarily an herbaceous dominated community. During the site inspection conducted on August 23, 2002, no established surface hydrologic connection was observed connecting Wetland A to any nearby water(s). Rather, the polygon appears to be depressional, surrounded entirely by moderately higher ground. In addition, no subsurface natural or artificial drainage features were indentified within proximity of the wetland. As a result, Wetland A would be considered a geographically isolated, non-jurisdictional wetland.
