### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:**

Isolated Wetland A: Is a depressional isolated wetland, 1.6-ac in size located at 32.3203, -81.2457. The wetland is approximately 400 linear feet from the nearest potentially jurisdictional water, and approximately 5.15 miles from the nearest TNW (Savannah River) and  $\pm$  3,279



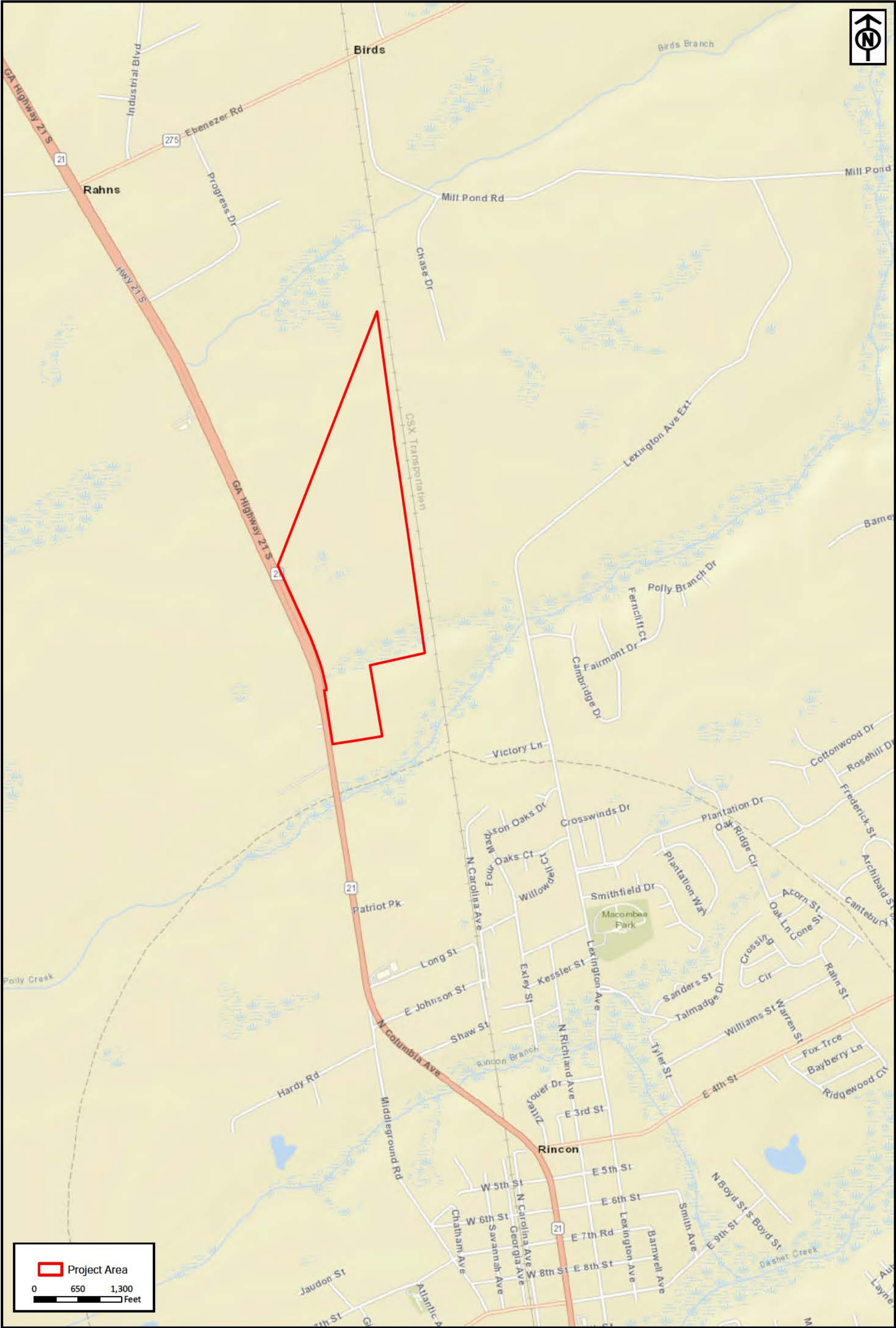
linear feet from the 100-year flood plain. The uplands surrounding the wetland are higher in elevation than the average surface elevation within the wetland. During the site inspection no surface connection such as ditches or swales were found between this wetland and other jurisdictional waters. Further there is no evidence of surface-water flow to or from the feature. Field inspection did not reveal a depressional surface feature between the isolated wetland to the nearest jurisdictional water, where water might flow during a major rainfall event. The soils located between the isolated wetland and the nearest jurisdictional wetland are mapped as MaA and RgA and are somewhat poorly drained and poorly drained by the NRCS. A shallow subsurface connection cannot be documented due to the distance from the isolated wetland to the nearest jurisdictional water. Based on observed site conditions, it appears that any subsurface flow would occur from the upland into the wetland.

Isolated Wetland B: Is a depressional isolated wetland 0.85-ac in size located at 32.3197, -81.2447. The wetland is approximately 819 linear feet from the nearest potentially jurisdictional water, approximately 5.19 miles from the nearest TNW (Savannah River) and  $\pm 3,680$  linear feet from the 100-year flood plain. The uplands surrounding the wetland are higher in elevation than the average surface elevation within the wetland. During the site inspection no surface connection such as ditches or swales were found between this wetland and other jurisdictional waters. Further there is no evidence of surface-water flow to or from the feature. Field inspection did not reveal a depressional surface feature between the isolated wetland to the nearest jurisdictional water, where water might flow during a major rainfall event. The soils located between the isolated wetland and the nearest jurisdictional wetland are mapped as MaA and RgA and are somewhat poorly drained and poorly drained by the NRCS. A shallow subsurface connection cannot be documented due to the distance from the isolated wetland to the nearest jurisdictional water. Based on observed site conditions, it appears that any subsurface flow would occur from the upland into the wetland.

Isolated Wetland C: Is a depressional isolated wetland 1.6-ac in size located at 32.3207, -81.2420. The wetland is approximately 956 linear feet from the nearest potentially jurisdictional water, approximately 5.96 miles from the nearest TNW (Savannah River) and  $\pm 3,939$  linear feet from the 100-year flood plain. The uplands surrounding the wetland are higher in elevation than the average surface elevation within the wetland. During the site inspection no surface connection such as ditches or swales were found between this wetland and other jurisdictional waters. Further there is no evidence of surface-water flow to or from the feature. Field inspection did not reveal a depressional surface feature between the isolated wetland to the nearest jurisdictional water, where water might flow during a major rainfall event. The soils located between the isolated wetland and the nearest jurisdictional wetland are mapped as MaA and RgA and are somewhat poorly drained and poorly drained by the NRCS. A shallow subsurface connection cannot be documented due to the distance from the isolated wetland to the nearest jurisdictional water. Based on observed site conditions, it appears that any subsurface flow would occur from the upland into the wetland.

Borrow Pitt/open water: Appears to be an upland dug borrow pit/pond/open water, 2.58-ac in size located at 32.3192, -81.2430. The borrow pit is approximately 1,219 linear feet from the nearest potentially jurisdictional water, approximately 5.02 miles from the nearest TNW (Savannah River) and  $\pm 4,204$  linear feet from the 100-year flood plain. During the site inspection no surface connection such as ditches or swales were found between this borrow pit and other jurisdictional waters. Further there is no evidence of surface-water flow to or from the feature. Field inspection did not reveal a depressional surface feature between the borrow pit to the nearest jurisdictional water, where water might flow during a major rainfall event. The soils located between the borrow pit and the nearest jurisdictional wetland are mapped as MaA and RgA and are somewhat poorly drained and poorly drained by the NRCS. A shallow subsurface connection cannot be documented due to the distance from the borrow pit to the nearest jurisdictional water. Based on observed site conditions, it appears that any subsurface flow would occur from the upland into the borrow pit.
