This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Use of the pond ceased, causing the pond to dry up. However, the feature maintained sufficient saturation to develop attributes characteristic of an emergent wetland, allowing for a delineateable boundary. The wetland is depressional and surrounded by uplands. The feature north of W-2, outside of the review area, is also a remnant of a historic farm pond. The feature has reverted to uplands and does not have a delineateable boundary. The historic easterly drainage features associated with the previous farm ponds no longer exists and is now cultivated farmland.

W-2 is not an impoundment of an RPW or Non-RPW, appears to have been man-made in uplands, and is surrounded by an earthen berm that prevents a hydrologic connections to any other waters. W-2 is determined to be classified as a "Preamble Water", as per 33 CFR 328.3(c) (1986), "artificial lakes or ponds created by excavating and/or diking dry land to collect and retain water and which are used exclusively for such purposes as stock watering, irrigation, settling basins, or rice growing".
