This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: There is no natural or man-made discrete and/or confined surface water connection between or among the subject features and any other jurisdictional water. Further, there is no evidence of surface-water flow to or from these features. Therefore, during times of heavy precipitation, there is a very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into these features.

Consequently, based on a review of available mapping, as these features are not located immediately upslope of other jurisdictional waters, and based on their respective landscape positions, they do not appear to be a component of any recognizable hydrologic system and they also have no surface or subsurface hydrologic connection to any other jurisdictional water. The observations and findings for each feature are detailed as follows:

A WL 107 - The 13.29-acre wetland is located in the southwest portion of the review area. It is approximately 2,000 feet from the nearest jurisdictional water and approximately 5 miles from the nearest TNW, the Flint River. The area is located in an agricultural field. Therefore, during times of heavy precipitation, there is a very low probability that floodwaters would reach an elevation necessary for water to flow from other jurisdictional waters into this feature. The attached LIDAR indicates a possible depressional surface feature between the subject wetland and the nearest jurisdictional water. During the Corps site visit it was determined that there was an elevational rise between the subject wetland and the feature preventing any surface water flow out of the wetland. Additionally, test pits found no indication of inundation in the upper 24" of the soil in the area between the subject wetland and the depressional feature. Based on site conditions, it appears that any subsurface flow would occur from the upland into the wetland.

A WL 108 - The 1.46-acre wetland is located in the central portion of the review area. It is approximately 1,300 feet from the nearest jurisdictional water and approximately 5 miles from the nearest TNW, the Flint River. The area is located on the edge of an agricultural field. Therefore, during times of heavy precipitation, there is a very low probability that floodwaters would reach an elevation necessary for water to flow from other jurisdictional waters into this feature. The attached LIDAR does not depict a depressional surface feature between the isolated wetland the nearest jurisdictional water, where water might flow during a major rainfall event. During the Corps site visit an upland cut ditch was located on the edge of the wet land. It traveled approximately 200' before ending. There was no indication of flow through the ditch or beyond its end. Additionally, test pits found no indication of inundation in the upper 24" of the soil in the area between the subject wetland and the depressional feature. Based on site conditions, it appears that any subsurface flow would occur from the upland into the wetland.

A WL 109 - The 0.074-acre wetland is a small depressional wetland located west of A WL 107. It is approximately 2,000 feet from the nearest jurisdictional water and approximately 5 miles from the nearest TNW, the Flint River. The area is located in an agricultural field. Therefore, during times of heavy precipitation, there is a very low probability that floodwaters would reach an elevation necessary for water to flow from other jurisdictional waters into this feature. The attached LIDAR does not depict a depressional surface feature between the isolated wetland the nearest jurisdictional water, where water might flow during a major rainfall event. Based on site conditions, it appears that any subsurface flow would occur from the upland into the wetland.

B WL 9 - The 0.79-acre wetland is a depressional wetland located in the northern portion of the property. It is approximately 1,100 feet from the nearest jurisdictional water and approximately 5 miles from the nearest TNW, the Flint River. The area is located between two agricultural fields. Therefore, during times of heavy precipitation, there is a very low probability that floodwaters would reach an elevation necessary for water to flow from other jurisdictional waters into this feature. The attached LIDAR does not depict a depressional surface feature between the isolated wetland the nearest jurisdictional water, where water might flow during a major rainfall event. Based on site conditions, it appears that any subsurface flow would occur from the upland into the wetland..
