- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: 0.74-acre wetland (Wetland C) is located within the southwestern portion of the site. This wetland area is visible on all available historical aeriels and was utilized as an agricultural surface water drainage basin. In 2013, an industrial development and a compacted gravel building pad, along with three sediment sorting ponds, water lines, and fire hydrants were constructed on the site. The sediment sorting pond directly to the north of Wetland C is located at a higher elevation and contributes surface water run-off to Wetland C during times of heavy rainfall. The building pad

and industrial building area are also higher in elevation than Wetland C and contribute surface water drainage to Wetland C. During two of the three site visits (2/8 and 2/21/2022) performed by GEC, the water lines located along the northeastern portion of Wetland C were leaking significantly, thus contributing surface water to Wetland C (approximately five gallons ever three minutes, per client). During the third delineation on 8/30/2022, it was noted that the water line had been fixed and no leaks were observed. During this third site visit, no surface water was observed within Wetland C, and Wetland C had recently been mowed for farming. Wetland C appears to only be draining upland areas (agricultural fields) and does not supply water directly or indirectly to a TNW. There are no culverts/pipes/draining of Wetland C towards the north or east. An upland swale was observed east of Wetland C; however, no hydrologic connection was observed via pipe/culvert/ditch/topography. The NWI map recognizes Wetland C as an isolated emergent wetland feature, and the topographic map also shows this wetland as an isolated open water feature. Furthermore, Wetland C was not classified as an aquatic resource by the USACE in the JD that was previously issued under the number 200310560 on August 29, 2003.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Through an emailed request for information, our office inquired about a possible ditch drainage feature and/or additional streams (as viewed in StreamStats), however, the agent indicates that the property does not contain a stream at the location of the StreamStats findings. Our office also a ditch which is visible from aerial photographs, however, the agent has detailed that this feature did not contain any flow during past field events nor does this feature connect to Wetland C through any type of pipe or culvert. Based on the supporting information provided by the applicant, and our subsequent review of other additional, available supporting maps (LiDAR and StreamStats), we have determined that Wetland C is a non-jurisdictional, isolated wetland which would not connect by surface water connection to any other adjacent aquatic features.
