C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Ponds 1 and 2 are greater than 600 linear feet from the nearest potentially jurisdictional water and approximately 2 miles from the nearest TNW (Ogeechee River). During the site inspection no direct surface connection was found between these ponds and potentially jurisdictional waters. Based on observed site conditions and soil permeability, it appears that any subsurface flow would occur from adjacent uplands into the ponds. Ponds 1 and 2 were constructed pre-1986 and utilized as borrow pits.

Wetland 3: Is a depressional isolated wetland 0.44-ac in size located at 32.231541, -81.473006. The wetland is approximately 283 linear feet from the nearest potentially jurisdictional water. A site inspection was conducted on 20221115. No surface connection such as ditches or swales were found between this wetland and other jurisdictional waters. Further there was no evidence of surface-water flow to or from the feature. Field inspection did not reveal a depressional surface feature between the isolated wetland to the nearest jurisdictional water, where water might flow during a major rainfall event. The soils located between the isolated wetland and the nearest jurisdictional wetland are mapped as Ona sand, Rutledge sand, and Olustee fine sand by the NRCS. A shallow subsurface connection was not documented between the isolated wetland to the nearest jurisdictional water. Based on observed site conditions, it appears that any subsurface flow would occur from the upland into the wetland.

Wetland 5: Is a depressional isolated wetland 3.13-ac in size located at 32.227344, -81.475897. The wetland is approximately 551 linear feet from the nearest potentially jurisdictional water. A site inspection was conducted on 20221115. No surface connection such as ditches or swales were found between this wetland and other jurisdictional waters. Further there was no evidence of surface-water flow to or from the feature. Field inspection did not reveal a depressional surface feature between the isolated wetland to the nearest jurisdictional water, where water might flow during a major rainfall event. The soils located between the isolated wetland and the nearest jurisdictional wetland are mapped as Pelham loamy sand and Stilson loamy sand by the NRCS. A shallow subsurface connection was not documented between the isolated wetland to the nearest jurisdictional water. Based on observed site conditions, it appears that any subsurface flow would occur from the upland into the wetland.

Wetland 6: Is a depressional isolated wetland 0.98-ac in size located at 32.226056, -81.474514. The wetland is approximately 742 linear feet from the nearest potentially jurisdictional water. A site inspection was conducted on 20221115. No surface connection such as ditches or swales were found between this wetland and other jurisdictional waters. Further there was no evidence of surface-water flow to or from the feature. Field inspection did not reveal a depressional surface feature between the isolated wetland to the nearest jurisdictional water, where water might flow during a major rainfall event. The soils located between the isolated wetland and the nearest jurisdictional wetland are mapped as Pelham loamy sand and Stilson loamy sand by the NRCS. A shallow subsurface connection was not documented between the isolated wetland to the nearest jurisdictional water. Based on observed site conditions, it appears that any subsurface flow would occur from the upland into the wetland.

Wetland 13: Is a depressional isolated wetland 2.39-ac in size located at 32.231541, -81.473006. The wetland is approximately 237 linear feet from the nearest potentially jurisdictional water. A site inspection was conducted on 20221115. No surface connection such as ditches or swales were found between this wetland and other jurisdictional waters. Further there was no evidence of surface-water flow to or from the feature. Field inspection did not reveal a depressional surface feature between the isolated wetland to the nearest jurisdictional water, where water might flow during a major rainfall event. The soils located between the isolated wetland and the nearest jurisdictional wetland are mapped as Pelham loamy sand and Stilson loamy sand by the NRCS. A shallow subsurface connection was not documented between the isolated wetland to the nearest jurisdictional water. Based on observed site conditions, it appears that any subsurface flow would occur from the upland into the wetland.

Wetland 15: Is a depressional isolated wetland 0.17-ac in size located at 32.219211, -81.469209. The wetland is approximately 740 linear feet from the nearest potentially jurisdictional water. A site inspection was conducted on 20221115. No surface connection such as ditches or swales were found between this wetland and other jurisdictional waters. Further there was no evidence of surface-water flow to or from the feature. Field inspection did not reveal a depressional surface feature between the isolated wetland to the nearest jurisdictional water, where water might flow during a major rainfall event. The soils located between the isolated wetland and the nearest jurisdictional wetland are mapped as Pelham loamy sand and Stilson loamy sand by the NRCS. A shallow subsurface connection was not documented between the isolated wetland to the nearest jurisdictional water. Based on observed site conditions, it appears that any subsurface flow would occur from the upland into the wetland.

Wetland 16: Is a depressional isolated wetland 0.41-ac in size located at 32.218478, -81.469875. The wetland is approximately 1,083 linear feet from the nearest potentially jurisdictional water. A site inspection was conducted on 20221115. No surface connection such as ditches or swales were found between this wetland and other jurisdictional waters. Further there was no evidence of surface-water flow to or from the feature. Field inspection did not reveal a depressional surface feature between the isolated wetland to the nearest jurisdictional water, where water might flow during a major rainfall event. The soils located between the isolated wetland and the nearest jurisdictional wetland are mapped as Pelham loamy sand and Stilson loamy sand by the NRCS. A shallow subsurface connection was not documented between the isolated wetland to the nearest jurisdictional water. Based on observed site conditions, it appears that any subsurface flow would occur from the upland into the wetland.

The non-jurisdictional wetlands are isolated with no connection to any potential jurisdictional waters. The wetlands are greater than 140 linear feet from the nearest potentially jurisdictional water, and approximately 2 miles from the nearest TNW (Ogeechee River). Based on observed site conditions and soil permeability, it appears that any subsurface flow would occur from adjacent uplands into the non-jurisdictional wetlands.
