### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:**

Wetland E: Is a depressional isolated wetland 0.47-ac in size located at 31.787136, -81.360683. The wetland is approximately 270 linear feet from the nearest potentially jurisdictional water, 2: 0.90 miles from the nearest TNW (Blackbeard Creek). The uplands surrounding the



wetland are approximately 1-2 foot higher in elevation than the average surface elevation within the wetland. No surface connection such as ditches or swales were found between this wetland and other jurisdictional waters. Further there is no evidence of surface-water flow to or from the feature. Field inspection did not reveal a depressional surface feature between the isolated wetland to the nearest jurisdictional water, where water might flow during a major rainfall event. The soils located between the isolated wetland and the nearest jurisdictional wetland are mapped as Ellabelle loamy sand and Eulonia fine sandy loam by the NRCS. A shallow subsurface connection cannot be documented due to the distance from the isolated wetland to the nearest jurisdictional water. Based on observed site conditions, it appears that any subsurface flow would occur from the upland into the wetland.

Wetland EE: Is a depressional isolated wetland 2.09-ac in size located at 31.787905, -81.364498. The wetland is approximately 629 linear feet from the nearest potentially jurisdictional water, 2:: 1.01 miles from the nearest TNW (Blackbeard Creek). The uplands surrounding the wetland are approximately 1-2 foot higher in elevation than the average surface elevation within the wetland. No surface connection such as ditches or swales were found between this wetland and other jurisdictional waters. Further there is no evidence of surface-water flow to or from the feature. Field inspection did not reveal a depressional surface feature between the isolated wetland to the nearest jurisdictional water, where water might flow during a major rainfall event. The soils located between the isolated wetland and the nearest jurisdictional wetland are mapped as Ellabelle loamy sand and Riceboro loamy fine sand by the NRCS. A shallow subsurface connection cannot be documented due to the distance from the isolated wetland to the nearest jurisdictional water. Based on observed site conditions, it appears that any subsurface flow would occur from the upland into the wetland.

Wetland H: Is a depressional isolated wetland 1.44-ac in size located at 31.789324, -81.358049. The wetland is approximately 613 linear feet from the nearest potentially jurisdictional water, 2:: 0.62 miles from the nearest TNW (Blackbeard Creek). The uplands surrounding the wetland are approximately 1-2 foot higher in elevation than the average surface elevation within the wetland. No surface connection such as ditches or swales were found between this wetland and other jurisdictional waters. Further there is no evidence of surface-water flow to or from the feature. Field inspection did not reveal a depressional surface feature between the isolated wetland to the nearest jurisdictional water, where water might flow during a major rainfall event. The soils located between the isolated wetland and the nearest jurisdictional wetland are mapped as Ocilla loamy fine sand and Eulonia fine sandy loam by the NRCS. A shallow subsurface connection cannot be documented due to the distance from the isolated wetland to the nearest jurisdictional water. Based on observed site conditions, it appears that any subsurface flow would occur from the upland into the wetland.

Wetland M: Is a depressional isolated wetland 0.94-ac in size located at 31.788588, -81.361609. The wetland is approximately 776 linear feet from the nearest potentially jurisdictional water, 2:: 0.82 miles from the nearest TNW (Blackbeard Creek). The uplands surrounding the wetland are approximately 1-2 foot higher in elevation than the average surface elevation within the wetland. During the site inspection no surface connection such as ditches or swales were found between this wetland and other jurisdictional waters. Further there is no evidence of surface-water flow to or from the feature. Field inspection did not reveal a depressional surface feature between the isolated wetland to the nearest jurisdictional water, where water might flow during a major rainfall event. The soils located between the isolated wetland and the nearest jurisdictional wetland are mapped as Ocilla loamy fine sand and Mascotte fine sand by the NRCS. A shallow subsurface connection cannot be documented due to the distance from the isolated wetland to the nearest jurisdictional water. Based on observed site conditions, it appears that any subsurface flow would occur from the upland into the wetland.
