C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Wetland 2 is approximately 0.61 acres and is located at 31.762426, -81.446068. The wetland is located approximately 1,300 feet from the nearest jurisdictional water, 3,000 feet from the nearest TNW (Peacock Creek), and 1,300 feet from the 100-Year Floodplain. No surface connections, such as ditches or swales, were observed during the on site investigation between the wetland and other jurisdictional waters.

The soils surrounding said wetland are Ocilla Loamy Fine Sand and Riceboro Loamy Fine Sand. Both soils have a drainage class of somewhat poorly drained. These soils are rated as hydric but are typical in depressions and bays. During the on-site investigation, soil pits were examined between said wetland and the closest jurisdictional water, no evidence of a sub-surface connection was observed. The on-site investigation validated that it is very unlikely that a subsurface connection exists from said wetland to other jurisdictional waters.

Wetland 3 is approximately 0.35 acres and is located at 31.762498, -81.443388. The wetland is located approximately 1,800 feet from the nearest jurisdictional water, 2,300 feet from the nearest TNW (Peacock Creek), and 1,800 feet from the 100-Year Floodplain. No surface connections, such as ditches or swales, were observed during the on site investigation between the wetland and other jurisdictional waters. The soils surrounding the wetland are comprised of loamy fine sands with a drainage class of somewhat poorly drained. The soils surrounding said wetland are Ocilla Loamy Fine Sand and Riceboro Loamy Fine Sand. Both soils have a drainage class of somewhat poorly drained. These soils are rated as hydric but are typical in depressions and bays. During the on-site investigation, soil pits were examined between said wetland and the closest jurisdictional water, no evidence of a sub-surface connection was observed. The on-site investigation validated that it is very unlikely that a subsurface connection exists from said wetland to other jurisdictional waters.

Wetland 4 is approximately 1.10 acres and is located at 31.759974, -81.440449. The wetland is located approximately 1,200 feet from the nearest jurisdictional water, 2,800 feet from the nearest TNW (Peacock Creek), and 1,200 feet from the 100-Year Floodplain. No surface connections, such as ditches or swales, were observed during the on site investigation between the wetland and other jurisdictional waters. The soils surrounding said wetland are Ocilla Loamy Fine Sand and Riceboro Loamy Fine Sand. Both soils have a drainage class of somewhat poorly drained. These soils are rated as hydric but are typical in depressions and bays. During the on-site investigation, soil pits were examined between said wetland and the closest jurisdictional water, no evidence of a sub-surface connection was observed. No surface connections, such as ditches or swales, were observed during the on site investigation between the wetland and other jurisdictional waters. The soils surrounding said wetland are Bladen Fine Sandy Loam, Ocilla Loamy Fine Sand and Riceboro Loamy Fine Sand. Both soils have a drainage class of somewhat poorly drained. These soils are rated as hydric but are typical in flats, depressions and bays. During the on-site investigation, soil pits were examined between said wetland and the closest jurisdictional water, no evidence of a sub-surface connection was observed. The on-site investigation validated that it is very unlikely that a subsurface connection exists from said wetland to other jurisdictional waters.

Wetland 6 is approximately 0.69 acres and is located at 31.758655, -81.440336. The wetland is located approximately 915 feet from the nearest jurisdictional water, 3,800 feet from the nearest TNW (Riceboro Creek), and 915 feet from the 100-Year Floodplain. No surface connections, such as ditches or swales, were observed during the on site investigation between the wetland and other jurisdictional waters. The soils surrounding said wetland are Ocilla Loamy Fine Sand, which has a drainage class of somewhat poorly drained. This soil type is rated as hydric but is typical in depressions. During the on-site investigation, soil pits were examined between said wetland and the closest jurisdictional water, no evidence of a sub-surface connection was observed. The on-site investigation validated that it is very unlikely that a subsurface connection exists from said wetland to other jurisdictional waters.

Wetland 7 is approximately 1.38 acres and is located at 31.758429, -81.439356. The wetland is located approximately 615 feet from the nearest jurisdictional water, 3,400 feet from the nearest TNW (Riceboro Creek), and 615 feet from the 100-Year Floodplain. No surface connections, such as ditches or swales, were observed during the on site investigation between the wetland and other jurisdictional waters. The soils surrounding said wetland are Bayboro Loam and Ocilla Loamy Fine Sand. Both soils have a drainage class of poorly drained. These soils are rated as hydric but are typical in depressions. During the on-site investigation, soil pits were examined between said wetland and the closest jurisdictional water, no evidence of a sub-surface connection was observed. The on-site investigation validated that it is very unlikely that a subsurface connection exists from said wetland to other jurisdictional waters.

Wetland 8 is approximately 2.40 acres and is located at 31.755980, -81.441617. The wetland is located approximately 300 feet from the nearest jurisdictional water, 2,000 feet from the nearest TNW (Riceboro Creek), and 300 feet from the 100-Year Floodplain. No surface connections, such as ditches or swales, were observed during the on site investigation between the wetland and other jurisdictional waters. The soils surrounding said wetland are Ocilla Loamy Fine Sand and Riceboro Loamy Fine Sand. Both soils have a drainage class of somewhat poorly drained. These soils are rated as hydric but are typical in depressions and bays. The soils surrounding said wetland are Bayboro Loam and Riceboro Loamy Fine Sand. Both soils have a drainage class of poorly drained. These soils are rated as hydric but are typical in depressions and flats. During the on-site investigation, soil pits were examined between said wetland and the closest jurisdictional water, no evidence of a sub-surface connection was observed. The on-site investigation validated that it is very unlikely that a subsurface connection exists from said wetland to other jurisdictional waters.

Wetland 12 is approximately 0.31 acres and is located at 31.763452, -81.438279. The wetland is located approximately 315 feet from the nearest jurisdictional water, 1,400 feet from the nearest TNW (Peacock Creek), and 550 feet from the 100-Year Floodplain. No surface connections, such as ditches or swales, were observed during the on site investigation between the wetland and other jurisdictional waters.

The soils surrounding said wetland are Albany Loamy Fine Sand and Ocilla Loamy Fine Sand. Both soils have a drainage class of poorly drained. These soils are rated as hydric but are typical in depressions. During the on-site investigation, soil pits were examined between said wetland and the closest jurisdictional water, no evidence of a sub-surface connection was observed. The on-site investigation validated that it is very unlikely that a subsurface connection exists from said wetland to other jurisdictional waters.

Wetland 14 is approximately 0.14 acres and is located at 31.757103, -81.428507. The wetland is located approximately 340 feet from the nearest jurisdictional water, 1,500 feet from the nearest TNW (Peacock Creek), and 340 feet from the 100-Year Floodplain. No surface connections, such as ditches or swales, were observed during the on site investigation between the wetland and other jurisdictional waters. The soils surrounding said wetland are Ocilla Loamy Fine Sand. This soil type has a drainage class of poorly drained and is rated as hydric but are typical in depressions. During the on-site investigation, soil pits were examined between said wetland and the closest jurisdictional water, no evidence of a sub-surface connection was observed. The on-site investigation validated that it is very unlikely that a subsurface connection exists from said wetland to other jurisdictional waters..
