C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Isolated Wetland 1 is approximately 0.39-acres and is located at 32.076779, -81.196957. The wetland is located approximately 1,200 feet from the nearest jurisdictional water, 1,100 feet from the nearest TNW (Savannah Ogeechee Canal), and 1,500 feet from the 100-Year Floodplain. During the delineation, no surface connections, such as ditches or swales, were found between this wetland and other

jurisdictional waters. The soils within the wetland are comprised of loamy fine sands with a drainage class of poorly drained. These soils are rated as hydric, but have enough permeability to limit subsurface flow from the wetland to other jurisdictional waters. As displayed in the LiDAR within Figure 6, this wetland is surrounded by higher elevation contours as well as developed roads and commercial sites visible on Figure 7.

Isolated Wetland 2 is approximately 3.14-acres and is located at 32.077590, -81.197738. The wetland is located approximately 400 feet from the nearest jurisdictional water, 500 feet from the nearest TNW (Savannah Ogeechee Canal), and 950 feet from the 100-Year Floodplain. During the delineation, no surface connections, such as ditches or swales, were found between this wetland and other jurisdictional waters. A portion of the soils within the wetland are comprised of loamy fine sands with a drainage class of poorly drained. These soils are rated as hydric, but have enough permeability to limit subsurface flow from the wetland to other jurisdictional waters. However, the majority of the soils within the wetland are comprised of urban complex soils with a drainage class of somewhat poorly drained. These soils are not rated as hydric and have ample permeability to limit surface and subsurface flow from the wetland to other jurisdictional waters. As displayed on the attached LiDAR in Figure 6, the wetland is well contained by contours of higher elevation which represent uplands on and off the site.
