C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The perennial stream channel is depicted on Street maps, google maps, NWI maps, and NHD maps, and the site inspection confirmed the presence of the perennial stream channel located within the northwestern corner of the

review area. The channel was impounded with the construction of Sharp Mountain Parkway, a privately owned roadway, to provide access to a gated residential community (The Preserve at Sharp Mountain). The roadway and earthen dam were constructed between 1999 and 2005 according to available historic aerial imagery. The extent of the perennial stream channel within the project review area is approximately 100 linear feet and the width of the channel ranges from 5-8 feet. There is approximately 50 linear feet of intermittent stream channel located to the east of the impoundment. The width of the intermittent stream channel ranges from 2-4 feet. The impoundment is approximately 0.25-acre and was constructed within the perennial stream channel. There is an existing outlet control structure located at the downstream end of the impoundment to allow water to flow downstream. There is an existing pipe that allows the intermittent stream to flow into the impoundment. There is an existing pedestrian bridge located at the upstream/inlet to the impoundment. The perennial stream channel is not piped at the inlet/upstream end of the impoundment. The earthen dam is between 10-12 feet in height, with Sharp Mountain Parkway located at the top of the earthen dam. The outlet control structure is a large culvert pipe located near the earthen dam/ roadway, and there is an elbow with a culvert that extends to the downstream segment of the perennial stream channel, on the southern side of the roadway. The perennial stream channel is an unnamed tributary to Sharp Mountain Creek and flows from north to south across the site, through the impoundment, to the confluence with Sharp Mountain Creek. Pettit Creek is depicted on mapping located north of the JD review area. The on-site waters flow to Sharp Mountain Creek, to the Etowah River, through Lake Allatoona, which is currently utilized for water recreation, and then into the Coosa River, a TNW, under Section 10 of the Rivers and Harbors Act. No adjacent wetland areas were identified on-site within the project review area during the Corps site inspection. The perennial stream channel has continuous flow, shelving, sediments sorting, lack of vegetation/ leaf litter within the channel, defined bed and banks, riffle/run/pool complexes, exposed tree roots, and sinuosity. The intermittent stream channel has base flow, lack of vegetation/ leaf litter within the channel, some sediment sorting and was shallow (1-2 inches deep) and narrow, with minor sinuosity, located outside of the project review area.
