I refer to a letter dated October 27, 2023, submitted on your behalf by [REDACTED], requesting an Aquatic Resources Delineation Review (ARDR) and an Approved Jurisdictional Determination (AJD) for a 5.48-acre site located at southeast of the intersection of Acorn Lane and Packinghouse Road in Statesboro, Bulloch County, Georgia (Latitude 32.458443, Longitude - 81.767295). This project has been assigned number SAS-2023-00864 and it is important that you refer to this number in all communication concerning this matter.

We have completed an ARDR and an approved AJD for this site. Any wetlands on-site were delineated in accordance with criteria contained in the 1987 "Corps of Engineers Wetland Delineation Manual," as amended by the most recent regional supplements to the manual. I have enclosed an "AJD Memorandum for Record," which details whether aquatic resources present on the site within the AJD review area, which is 0.54 acres within the 5.48-acre site are subject to the jurisdiction of the U.S. Army Corps of Engineers and how the Corps determined jurisdiction. The enclosed exhibit entitled, "Aquatic Resource GPS Delineation Exhibit", dated November 1, 2023, accurately identifies the delineated limits of all aquatic resources located within the review area.

"Upland Dug Pond" as depicted on the enclosed the aforementioned exhibit are not a water of the United States and are therefore not within the jurisdiction of Section 404 of the Clean Water Act (33 United States Code § 1344). The placement of dredged or fill material into non-jurisdictional waters would not require prior Department of the Army authorization pursuant to Section 404. The above referenced exhibit also identifies the delineation limits of all other aquatic resources within the review area.

This approved JD will remain valid for a period of 5-years unless new information warrants revision prior to that date. You may request an administrative appeal for any approved JD under the Corps regulations at 33 Code of Federal Regulations (CFR) Part 331. Enclosed you will find a Notification of Administrative Appeal Options and Process and Request for Appeal form.

The delineation included herein has been conducted to identify the location and extent of the aquatic resource boundaries and/or the jurisdictional status of aquatic resources for purposes of the Clean Water Act for the particular site identified in this request. This delineation and/or jurisdictional determination may not be valid for the Wetland Conservation Provisions of the Food Security Act of 1985, as amended. If you or your tenant are USDA program participants, or anticipate participation in USDA programs, you should discuss the applicability of a certified wetland determination with the local USDA service center, prior to starting work.

If you intend to sell property that is part of a project that requires Department of the Army Authorization, it may be subject to the Interstate Land Sales Full Disclosure Act. The Property Report required by Housing and Urban Development Regulation must state whether, or not a permit for the development has been applied for, issued or denied by the U.S. Army Corps of Engineers (Part 320.3(h) of Title 33 of the CFR).

This communication does not convey any property rights, either in real estate or material, or any exclusive privileges. It does not authorize any injury to property, invasion of rights, or any infringement of federal, state or local laws, or regulations. It does not obviate your requirement to obtain state or local assent required by law for the development of this property. 
