MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime
Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322
(2023),¹ SAS-2023-00947 MFR 1 or 1²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States,'" as

Wetland A	0.11	Wetland lacks a continuous surface connection to water of the US. This wetland is a historically manmade feature that has naturalized into a depressional wetland that is surrounded by uplands. Based on a site visit conducted on May 6, 2024, and contour lines from LIDAR, the Corps has determined there is no discrete feature present that would constitute a continuous surface connection to an a(1)-a(6) water. Additionally, there is no evidence that this wetland has subsurface connections below the adjacent uplands.
Wetland B	0.08	Wetland lacks a continuous surface connection to water of the US. This wetland is a historically manmade feature that has naturalized into a depressional wetland that is surrounded by uplands. Based on a site visit conducted on May 6, 2024, and contour lines from LIDAR, the Corps has determined there is no discrete feature present that would constitute a continuous surface connection to an a(1)-a(6) water. Additionally, there is no evidence that this wetland has subsurface connections below the adjacent uplands.
Wetland C	0.68	Wetland lacks a continuous surface connection to water of the US. This wetland is a depressional wetland that is surrounded by uplands. Based on a site visit conducted on May 6, 2024, and contour lines from LIDAR, the Corps has determined there is no discrete feature present that would constitute a continuous surface connection to an a(1)-a(6) water.

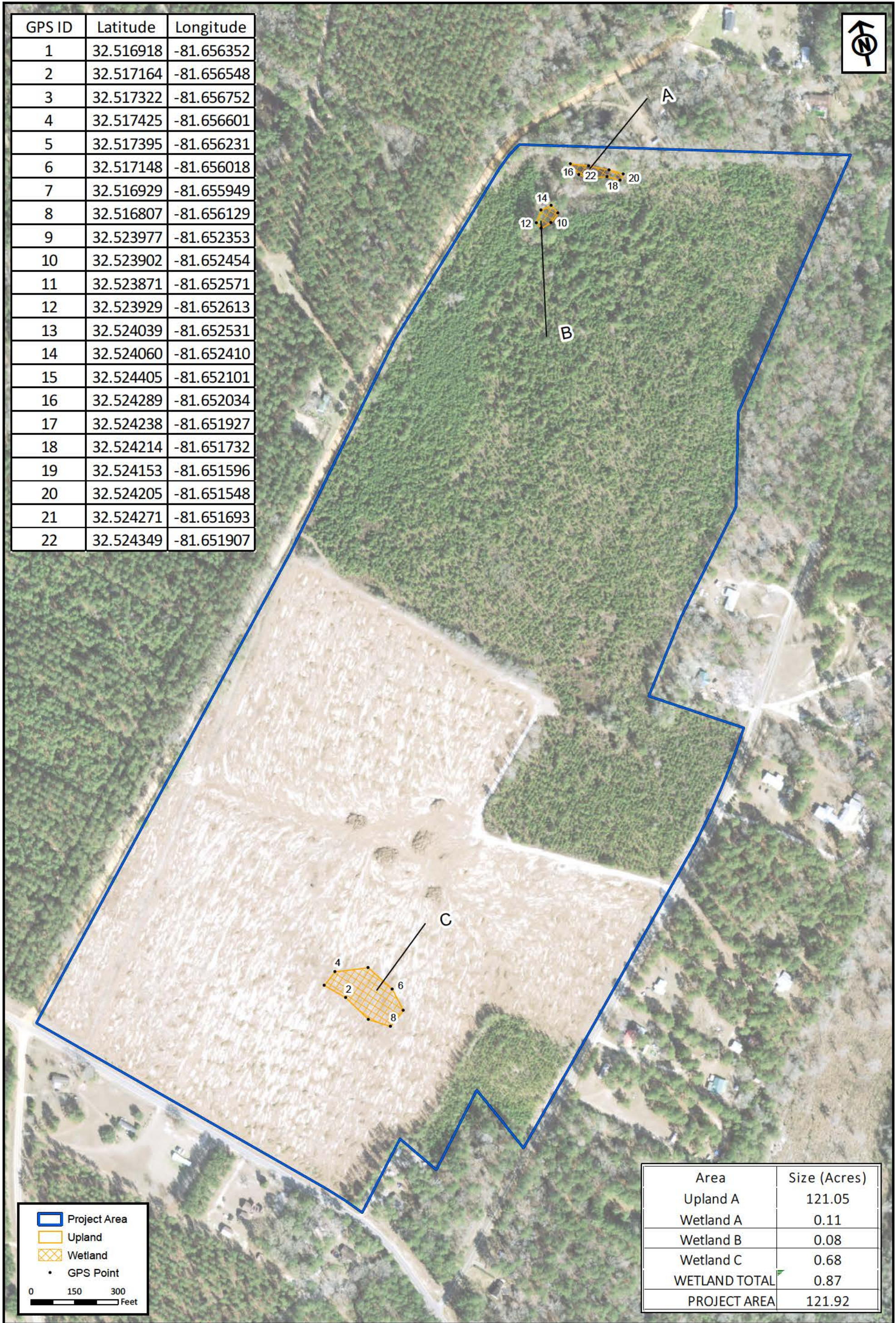
