MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime
Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322
(2023),¹ SAS-2023-00513 (MFR 1 of 1)²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of “waters of the United States” found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 “Revised Definition of ‘Waters of the United States,’” as

Pond 1	1.11	This pond is an artificial pond created by excavating dry land to collect and retain water. It is used exclusively for such purposes as stock watering, irrigation, or settling basins. This pond is surrounded by and draining only uplands. As seen on historic topographic maps, this pond was constructed after 1966 in areas not labelled as wetlands.
Pond 2	0.69	This pond is an artificial pond created by excavating dry land to collect and retain water. It is used exclusively for such purposes as stock watering, irrigation, or settling basins. This pond is surrounded by and draining only uplands. As seen on historic topographic maps, this pond was constructed after 1966 in areas not labelled as wetlands.

Name of excluded feature	Size (in acres)	Type of resource generally not jurisdictional
Ditch	0.4	This is an artificial ditch excavated wholly in uplands that does not carry a relatively permanent flow. The ditch did not exhibit an ordinary high water mark or exhibit the three wetland characteristics. Although the ditch is listed as riverine on NWI and NHD, there was no flowing water during two separate Corps site visits. As seen on historic topographic maps, this ditch was constructed after 1966 in areas not labelled as wetlands.

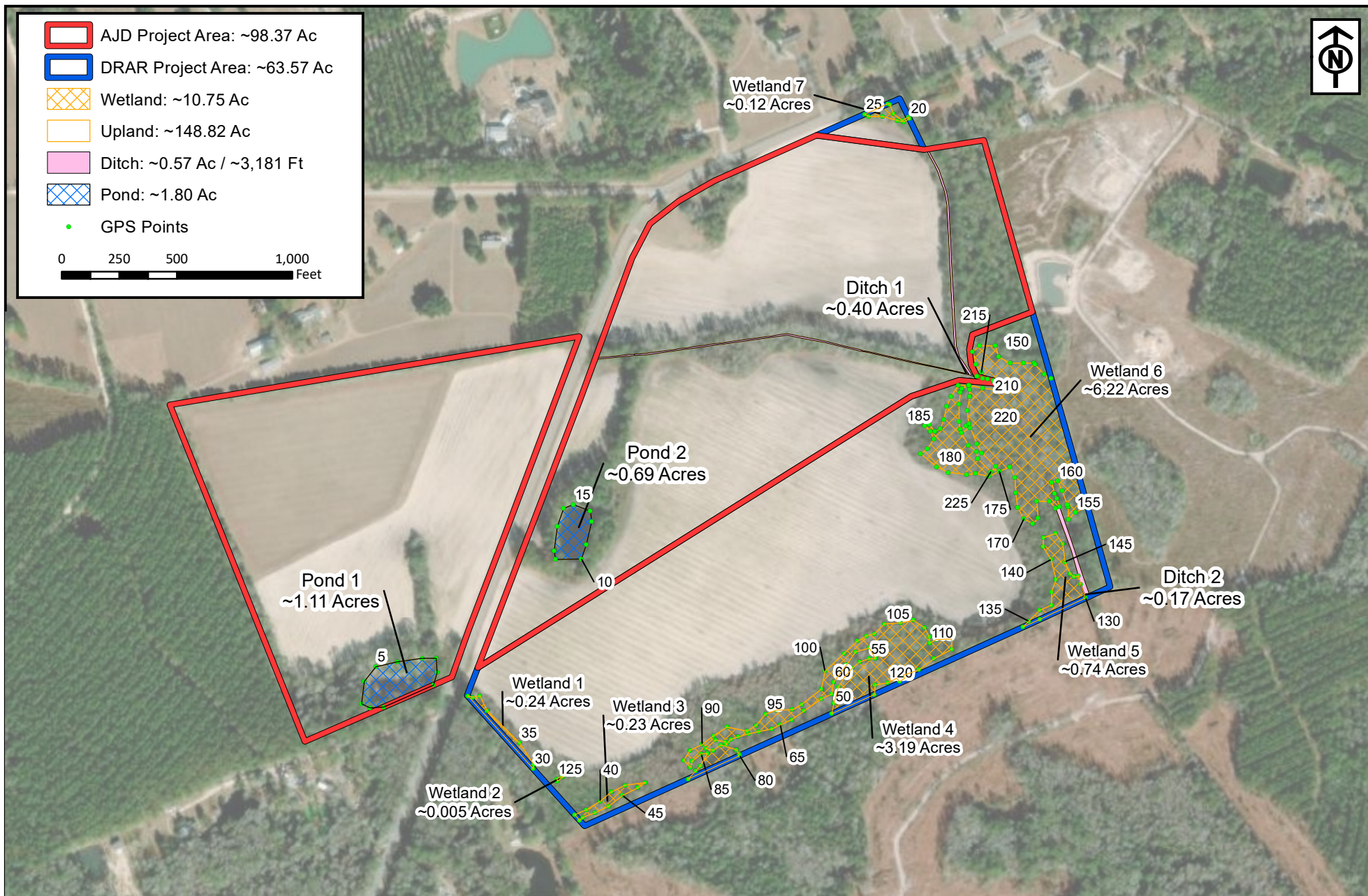
