MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023), 1 SAS-2012-01041 (MFR 1 of 1)²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating iurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States," as

On March 12, 2025, new guidance from Army Corps Headquarters changed the parameters for a continuous surface connection. As a result, the current jurisdictional determination for these resources has changed to non-jurisdictional.

Name of excluded feature	Size (in acres)	Type of resource generally not jurisdictional
M1	4.4	Wetland M1 is surrounded by uplands on all sides. There is a road to the west of this wetland that separates M1 from N1. This wetland does not have a continuous surface connection to water of the US. Due to lack of connectivity, wetland M1 is non-jurisdictional.
N1	6.69	Wetland N1 is surrounded by uplands on all sides. There is a road to the east of this wetland that separates M1 from N1. There is a ditch (labeled as D2) to the west of N1. See D2 below for more details. This wetland does not have a continuous surface connection to water of the US. Due to lack of connectivity, wetland N1 is non-jurisdictional.
D2	0.03	Ditch D2 is a non-relatively permanent water. D2 is an unmaintained ditch that does not exhibit an Ordinary High Water Mark nor exhibit the three wetland characteristics. Since D2 does not carry intermittent or perennial flow, D2 is not acting as a continuous surface connection. As a result, the two wetlands to the east of this ditch lack a connectivity to water of the US.
