MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime
Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322
(2023),¹ SAS-2024-00297 (MFR 1 of 1)²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of “waters of the United States” found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. 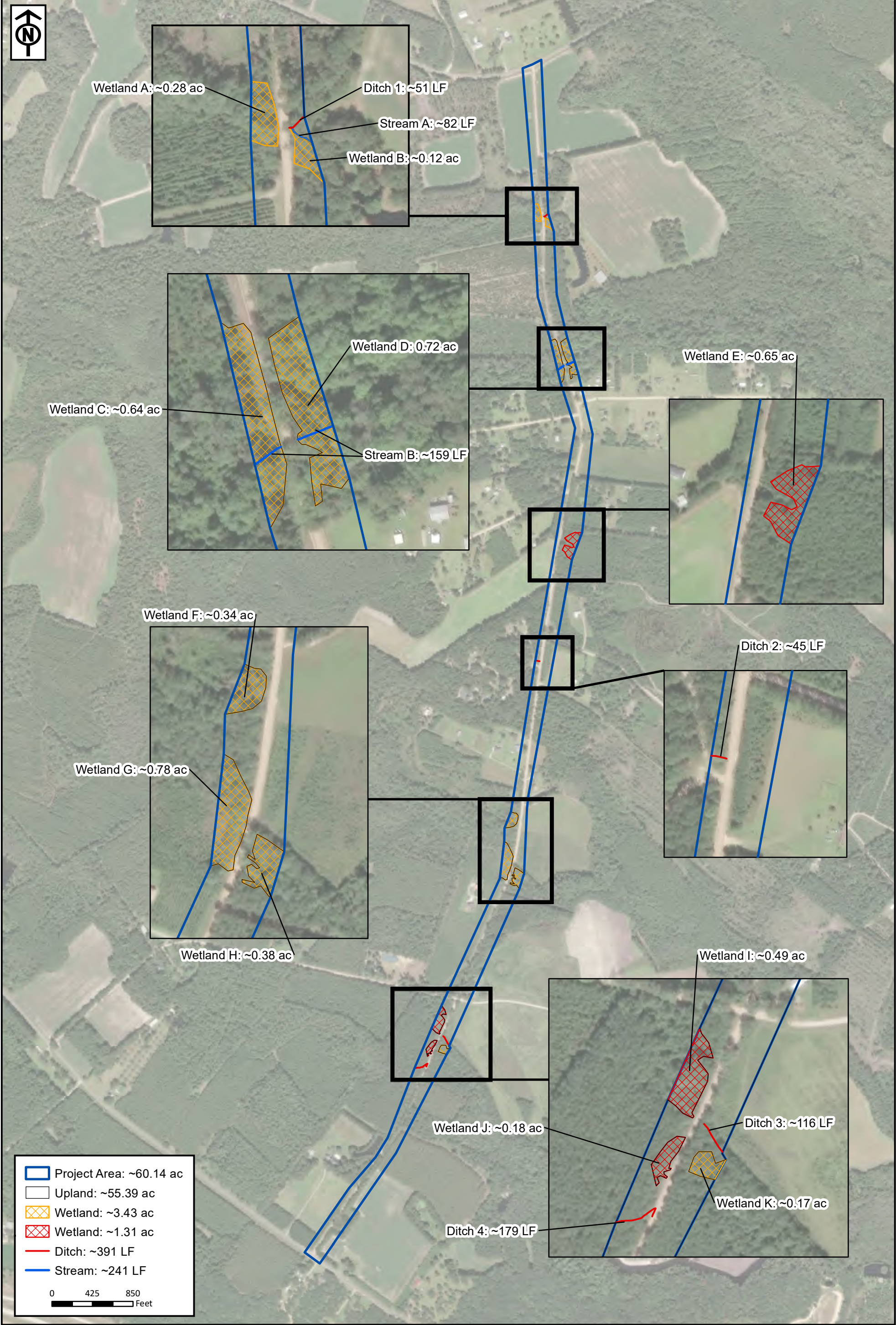

Name of excluded feature	Size (in acres or linear feet)	Type of resource determined to be not jurisdictional
Wetland E	0.65 acre	Wetland E is surrounded by uplands on all sides. Wetland E does not have a continuous surface connection to a water of the U.S. Due to lack of connectivity, Wetland E is non-jurisdictional.
Wetland I	0.49 acre	Wetland I is surrounded by uplands on all sides. There is a road (Old Happy Road) to the east of this wetland that separates Wetland I from Wetland K. There is a ditch (labeled as Ditch 3) to the east of Wetland I. See Ditch 3 below for more details. Wetland I does not have a continuous surface connection to water of the US. Due to lack of connectivity, Wetland I is non-jurisdictional.
Wetland J	0.18 acre	Wetland J is surrounded by uplands on all sides. There is a road (Old Happy Road) to the east of this wetland that separates Wetland J from Wetland K. There is a ditch (labeled as Ditch 3) to the east of Wetland J. See Ditch 3 below for more details. Wetland J does not have a continuous surface connection to water of the U.S. Due to lack of connectivity, wetland I is non-jurisdictional.
Ditch 1	linear feet	Ditch 1 is a non-relatively permanent water. Ditch 1 is an unmaintained ditch that does not exhibit an Ordinary High Water Mark nor exhibit the three wetland characteristics, therefore, Ditch A is non-jurisdictional.
Ditch 2	45 linear feet	Ditch 2 is a non-relatively permanent water. Ditch 2 is an unmaintained ditch that does not exhibit an Ordinary High Water Mark nor exhibit the three wetland characteristics. Since Ditch 2 does not carry intermittent or perennial flow, Ditch B is not acting as a continuous surface connection to Wetland I and Wetland J. As a result, Wetland I and Wetland J, to the west of Old Happy Road, lack connectivity to a water of the U.S.
Ditch 3	116 linear feet	Ditch 3 is a non-relatively permanent water. Ditch 3 is an unmaintained ditch that does not exhibit an Ordinary High Water Mark nor exhibit the three wetland characteristics, therefore, Ditch 3 is non-jurisdictional.
Ditch 4	179 linear feet	Ditch 4 is a non-relatively permanent water. Ditch 4 is an unmaintained ditch that does not exhibit an Ordinary High Water Mark nor exhibit the three wetland characteristics, therefore, Ditch 4 is non-jurisdictional.
