C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The review area contains 0.166 acre of isolated wetland and 0.834 acre of Upland.

There are no surface or subsurface hydrologic connections between the non-jurisdictional isolated wetland and any jurisdictional waters. This isolated wetland is greater than 2.8 river miles from the nearest TNW. On average the uplands immediately adjacent to the isolated wetlands are at least 2 feet higher in elevation than the surface elevation within the isolated wetland. While the isolated wetland is located at a higher elevation than the nearest jurisdictional wetland, no evidence of surface or subsurface hydrologic connections were found between the features. While soil textures are similar in the onsite uplands and wetlands (sandy loam textures), organic content is higher within the wetlands. Typical slopes of the uplands range from 1-4 percent while the isolated wetlands are flat with slopes less than 0.5 percent. As a result of slope, the upland soils drain more quickly than the wetland and are not likely to hold surface water or remain saturated for extended periods of time. This results in the absence of hydric soil indicators outside the delineated wetland boundary. The perimeter of the isolated wetland was investigated for the presence of ditches, swales, or other types of hydrologic connection to jurisdictional wetlands. No such hydrologic connections were observed. A distinct and obvious transition to upland vegetative species was observed along the entire perimeter of the isolated wetland. Based on the surrounding soils, lack of hydrologic connection, and the remoteness to jurisdictional waters of the U.S., it is our opinion that the wetland is isolated and non-jurisdictional.
