C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

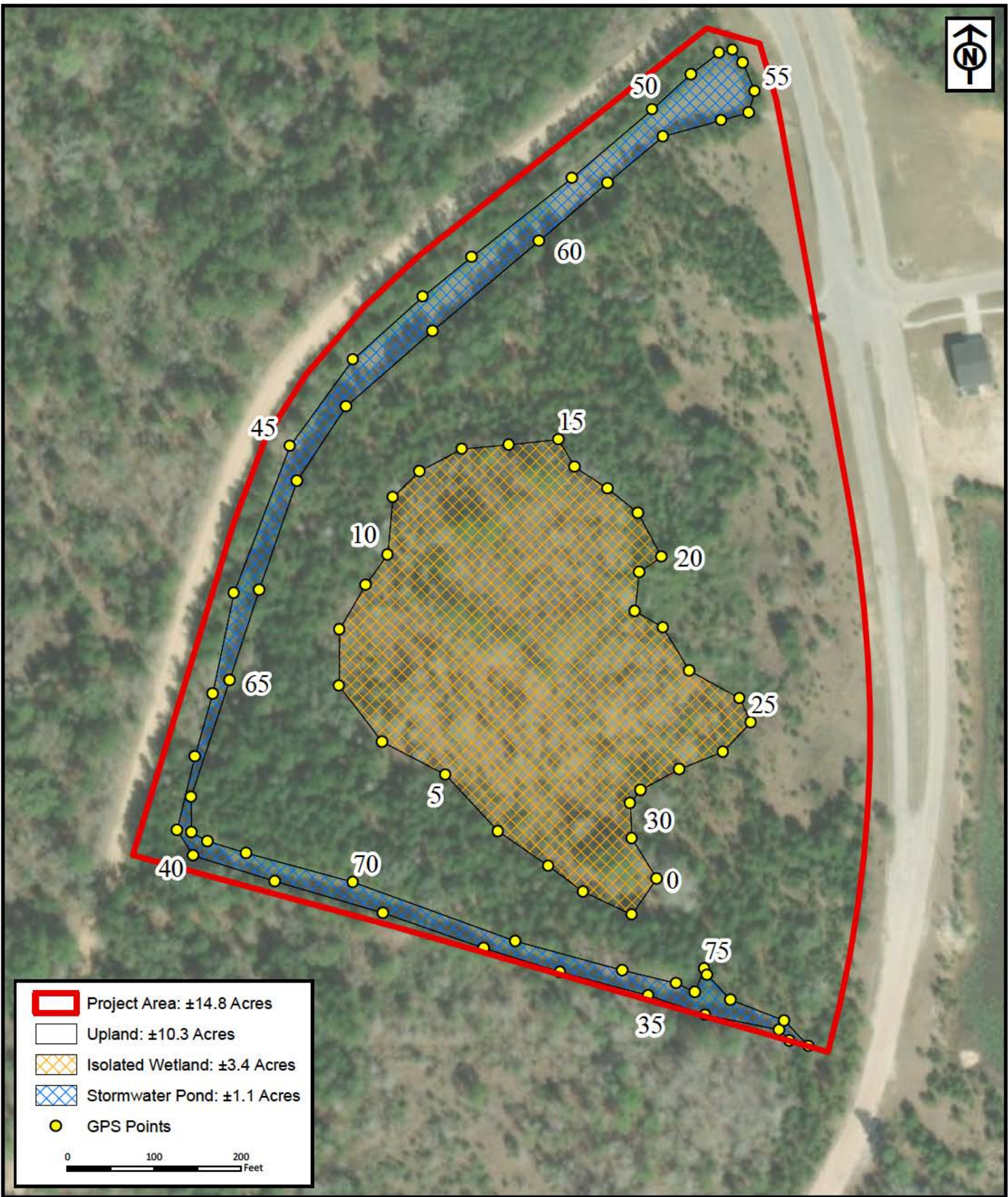

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The non-jurisdictional wetland (3.4-acres) is an isolated wetland located at 31.846486, -81.459486 . The wetland is +/-300-400 linear feet from the nearest potentially jurisdictional water, approximately ±6 miles from the nearest TNW (Blackbeard Creek) and is not located within the 100 year flood plain. During the site inspection no direct surface connection was found between this wetland and any potentially

jurisdictional waters. Based on observed site conditions it appears that any subsurface flow would occur from adjacent uplands into the wetland. A site visit by the Corps on January 5, 2023 verified that the wetland does not have any hydrologic connection to the stormwater pond located onsite. The wetland is isolated. The wetland was previously verified as non-jurisdictional by the USACE in a letter dated 12 May 2008. The 1.1 acre stormwater/detention pond located on site is upland dug and used for stormwater.
