B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: Project area is a narrow corridor within the road right-of-way of Fort Argyle Road. Area contains upland dug ditches directly adjacent to and adjoining upland dug roadside ditches verified as upland in a letter from USACE Savannah District dated September 16, 2016 (SAS-2016-00518).
