**B.** Typical year assessment(s): The data forms provided by Sligh Environmental indicate that they performed a wetland delineation of the project area on Feb 4, 2019. Based on the Antecedent Precipitation Tool Version 1.0, which used rainfall data from the Savannah International Airport weather station, we have determined that wetter than normal conditions were present for the nearest weather station on the date of the wetland delineation, which was completed in the wet season.
