B. Typical year assessment(s): The wetland jurisdictional status assessment was conducted on 03 November 2020. Using the Antecedent Precipitation Tool Version 1.0, which used rainfall data from the Woodbine weather station, we have determined that wetter than normal conditions were present during the time of the assessment.

C. Additional comments to support AJD: Non-adjacent Wetland A is surrounded entirely by upland. There is no direct hydrologic surface connection between Wetland A and any other jurisdictional wetlands. This wetland is greater than 2 miles from the nearest TNW, the St. Marys River.

Non-adjacent Wetland B drains through man-made ditch network to the south. Portions of the ditch were constructed within uplands and are therefore non-jurisdictional. This wetland is greater than 2 miles from the nearest TNW, the St. Marys River.

Non-Adjacent Wetland C is located within a cleared and mowed right of way. There is no direct hydrologic surface connection between Wetland C and any other jurisdictional wetlands. This wetland is greater than 2 miles from the nearest TNW, the St. Marys River.
