**B. Typical year assessment(s):** The data forms provided by Sligh Environmental Consultants, Inc. indicated that they performed a wetland delineation of the project area on 02/01/2021. Using the Antecedent Precipitation Tool Version 1.0, which used rainfall data from the Brooklet 1 W weather station, we have determined the delineation was conducted during the wet season (WebWIMP H2O Balance) and that "Wetter than Normal" rainfall conditions were present for the nearest weather station on the date of the wetland delineation.
