C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Pond A (0.51-acres) is a depressional bowl constructed without an outfall. Its located at 32.339604, -81.239205. The pond is +/-95 linear feet from the nearest potentialy jurisdictional water, approximately 4.5 miles from the nearest TNW (Savannah River) and +/-950 linear feet from the 100 year flood plain. During the site inspection no direct surface connection was found between this pond and potentially jurisdictional waters. Based on observed site conditions and soil permeability, it appears that any subsurface flow would occur from adjacent uplands into the pond.

Pond B (0.46-acres) is a depressional bowl constructed without an outfall. Its located at 32.341068, -81.239726. The pond is +/-635 linear feet from the nearest potentialy jurisdictional water, approximately 4.5 miles from the nearest TNW (Savannah River) and +/-1,450 linear feet from the 100 year flood plain. During the site inspection no direct surface connection was found between this pond and potentially jurisdictional waters. Based on observed site conditions and soil permeability, it appears that any subsurface flow would occur from adjacent uplands into the pond.

.
