The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?



B. ADDITIONAL COMMENTS TO SUPPORT JD:

Non Jurisdictional upland dug Borrow Pit A and B

The 0.41-acre borow pits are located approximately between 30-120 feet from the nearest potential jurisdiction waters, and approximately 3.2 miles from the nearest TNW (Ash Branch). During the inspection of this site, no surface connection (i.e., ditch, swale, etc.) was found between the borrow pits and other jurisdictional waters. The uplands surrounding the wetland are approximately 3-4 feet higher in elevation than the surface elevation of the isolated wetlands. The attached LIDAR image and topographic map do not depict a depressional surface feature between the isolated wetland and the nearest jurisdictional water, where water might flow during a major rainfall event. The upland soils located between the isolated wetland and the nearest potential jurisdictional wetland are mapped Olustee Fine Sand, which are considered somewhat poorly drained. Even though the upland soils are permeable, a shallow subsurface connection cannot be documented due to the distance from the isolated wetland to the nearest jurisdictional water. Historical imagery indicates that these pits were dug in uplands.
