Increasing the capacity of Savannah's Port will enable increased trade throughout the region, promote future growth, and create jobs for Georgia.

As a citizen of Georgia and one of the thousands of people who's job is tied to the port of Savannah I urge you to support the deepening of the harbor. The warehousing, truck, rail, and distribution network that currently flow through the port cannot be recreated without significant economic impact to the southeast and, some would argue, the entire country. One thing to keep in mind is the impact the opening of the Panama Canal will have on the flow of cargo to the east coast. The port of LA/Long (the largest terminal complex in the US in terms of volume) beach have implemented programs like Pier Pass, Alameda Corridor Tax, Clean truck that add from \$150 to \$200 in cost to each container that move through the terminal. Oakland and Seattle are implementing similar program. Importers and exporters are targeting east coast ports to avoid these costs. Combine projected population growth in the southeast with the economic benefits of the larger vessels and the cost savings associated with shifting from the west coast the need to deepen the Savannah terminal becomes clear. I urge you to support this initiative.

Having been in the transportation business for over 30 years and either worked for, with or along side of trucking companies, steamship lines, customhouse brokers , freight forwarders and warehouses,

I can tell you that the need for deepening the Savannah River is essential to the continued leadership of Savannah and the state of Georgia in the economic world as well as the economic growth of the Southeastern part of the United States.

Manufacturers and retailers have had to cut costs in all areas to keep up with this global economy that we find ourselves living in today. After all labor costs have been cut as far as they can, transportation costs are the next line item that has to be kept competitive to survive either in an export or import industry. With the carriers moving to larger vessels, they will have to bypass any port that cannot handle them. This will increase transportation costs for all shippers and receivers of cargo in the entire Southeastern area of the United States. 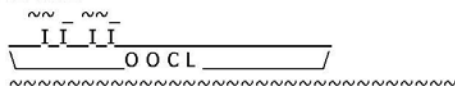

Kia Motors Manufacturing Georgia (KMMG) appreciates this opportunity to express support for the recommendations in the Army Corps of Engineers Draft General Re-evaluation Report and Environmental Impact Statement concerning the proposed Savannah Harbor Expansion Project. KMMG employs more than 2,000 workers at its West Point, Georgia facility, building Kia Sorento and Hyundai Santa Fe vehicles. Since opening in November 2009, KMMG has built about 170,000 vehicles.

Our West Point facility plays a critical role in Kia's manufacturing operations; of the 356,268 vehicles Kia sold in the U.S. since the beginning of 2010, 30% come from Georgia. And production at the West Point facility is growing at a healthy pace; KMMG currently has more than 2,500 team members and local suppliers are expected to create an additional 7,500 job in the area.

To build cars at West Point, KMMG receives certain car components via the Port of Savannah, which are then transported to our plant. In 2010, KMMG transported 1,400 containers from the Port of Savannah and our suppliers transported 2,300 containers. This will increase up to 3,500 for KMMG and 7,500 for our suppliers in the coming years. Because our business depends upon just-in-time delivery of many items, the ability to receive necessary components in a timely and reliable manner is critical to Kia. In fact, Kia's decision to build its \$1 billion facility in West Point was in no small measure due to the proximity of the Port of Savannah and the proliferation and continued growth of supplier companies in that area depend upon the Port.

KMMG commends the Port of Savannah for its efforts to operate as efficiently as possible under the current circumstances. However, we are concerned that existing challenges will become increasingly difficult to address. Savannah's Garden City terminal is the East Coast's second largest container port but at 42 feet deep, Savannah harbor is the shallowest of

the nation's top ten container ports. Currently, carriers are adapting to the shallow depth through measures such as waiting for high tide, light loading, using smaller vessels, or bypassing Savannah altogether. However, such measures can ultimately impact shippers like KMMG and supplier companies with which it works through decreased efficiency and reliability, and increased costs. These problems will only be exacerbated when the Panama Canal completes its expansion in 2014, allowing even larger ships to access the East Coast ports, more of which may bypass Savannah due to shallow harbor depth.

Accordingly, KMMG supports the Army Corp of Engineers' proposed expansion project for the Savannah Harbor, which will deepen the harbor to a sufficient depth to alleviate many of the navigational difficulties currently facing vessels, and to accommodate larger vessels capable of carrying more cargo. We believe the project will allow the Port of Savannah to maintain and enhance its economic contribution to the region and the nation, as the Corp of Engineers report concludes. What this means to KMMG as a shipper is logistical efficiency and reliability which, as mentioned, are critical to our operations. These enhancements will be especially important moving forward, because KMMG's efficiency and growth translates to much-needed jobs for the entire region.

Environmental concerns certainly should not be overlooked, and KMMG notes the Corps of Engineers' finding that allowing larger vessels to access the port could reduce air emissions because fewer of such vessels would be needed to carry cargo through the port. We also believe an expanded port would reduce or alleviate the instances of vessels bypassing Savannah in favor of more distant, deeper ports, which now forces some Georgia-area shippers to transport the cargo greater distances by truck.

Efficient operation of KMMG's supply logistics plays a key role in the ability of KMMG and its suppliers to grow. And efficient operation of the Port of Savannah, with the ability to expand its cargo capabilities, will help KMMG meet its expansion goals, to the ultimate benefit of the entire region. For these reasons, KMMG is pleased to express its support for the proposed Savannah Harbor expansion project.

I am writing to state, for the record, the importance of the Savannah Harbor Expansion Project. Our company currently utilizes the Port of Savannah as a major east coast gateway for import/exporting our products and provided adequate infrastructure is available, we plan to continue to grow our trade through the port for many years to come. However, the current -42 foot mean low water depth of the Savannah River is no longer sufficient to accommodate the post-Panamax vessels we rely on today to transport our goods. This deficiency will be more significant in the future as we expect larger containerhips to be introduced by carriers serving the US east coast upon completion of the Panama Canal expansion.

As you know, the newer post-Panamax vessels offer greater economic and environmental efficiencies that make their use both a preference as well as a priority to older generation vessels. SHEP is critical to the continued cost-effectiveness of our business and our ability to create jobs and reduce costs to U.S. consumers. By being able to load more boxes on fewer ships, our transportation costs are significantly decreased. Furthermore, ready access to the newer larger vessels at the Port of Savannah will avoid the higher financial and environmental costs of trucking our products to/from ports that are further from our markets and distribution network."
