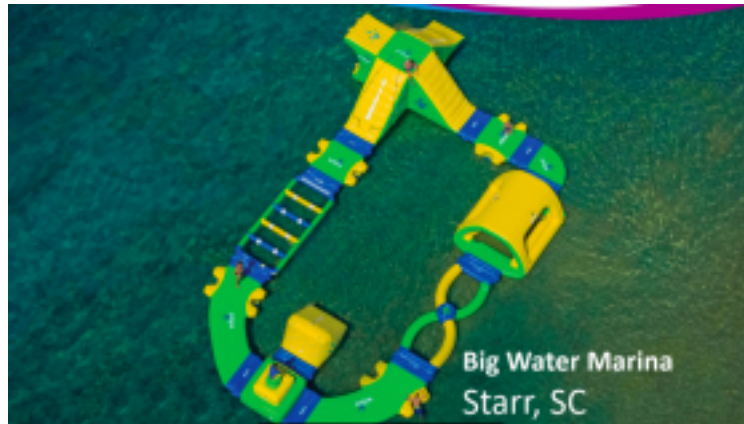


# Big Water Marina WIBIT Proposal



## General Information:

- The proposed hours of operation are 10 a.m.-5 p.m., Monday-Sunday, May-September.
- There will be two sessions each day from 10 a.m.-1 p.m. and 2-5 p.m.
- Each session pass is \$24.99 per participant and will be available for purchase at the check-in kiosk or online at the marina website.

## SAFETY

- All participants require a waiver for admission into the marina for the wibit.
- All activities are "at your own risk." The Wibit is monitored; however, participants are responsible for their own safety.
- Proper swim attire must be worn at all times - no denim, belts, cut-offs, sweats, cargo shorts, or any type of street wear will be allowed on the Wibit.
- Also, all accessories, such as watches, jewelry, earrings/piercings or similar items must be removed prior to using the water amenity. Fingernails (toenails) of length should be considered.

- Participants using the Wibit must wear a coast guard approved life-vest at all times (entering the play area, during use, and exiting)
- Wrist bands must remain on and visible during attendance
- Guests are to demonstrate behavior and language suited for a “family-friendly environment”
- H2O Entertainment/Big Water Marina is not responsible for lost or stolen items
- Rain Check – The Wibit may be closed due to bad weather - any customers who have been at the park for one hour or less will be issued a “Return Pass.”
- Guests with pre-existing conditions/illnesses should not participate if they are prone/at risk of serious injuries due to falling or slipping. This includes, but is not limited to those with hemophilia, brittle bones disease, multiple concussions, etc.
- Pregnant women are advised not to participate due to the slipping/falling risks
- Under no circumstances, are intoxicated individuals allowed to participate in this activity. If a guest appears/is intoxicated (or under the influence) they will be refused entry/access
- Carry-ins are allowed. Guests should carry out what they carry in. No Alcoholic beverages are allowed
- All participants must be able to swim.

### **Weight, Height, and Age Restrictions**

- Wibit participants must be at least 48 inches tall or at least 7 years old.
  - An attendant/staff will ensure all participants are the required height with the use of a height measurement stick.
  - Guardians/Parents must supervise children under the age of 13 who participate
  - In addition, children must be able to swim.
- Water Inflatable Total Weight Capacity: 660 pounds per piece or 9,900 pounds total
- Water Inflatable Capacity: 55 participants (some parts of the course allow only 2/4/6 people at a time).

# H2O ENTERTAINMENT SAFETY RULES

To ensure your safety on the inflatable obstacle course, waivers are required, and we request that participants comply with the following rules:

- Only use during hours of operation (10:00 AM - 5:00 PM)
- Only use in the presence of an on-duty attendant
- Do not play on the obstacle course during adverse weather conditions
- Do not jump from high objects or obstacles onto other players or unsafe objects
- Use all safety equipment properly, including lifejackets and ensure they are properly fitted
- Use the obstacle course properly and responsibly to avoid injuring yourself or others

Make sure there are no people or objects in the water before jumping from any portion of the obstacle course.

Diving underneath or head-first under any obstacles or in the water is not permitted.

Children under the age of 7 years old or under 48 inches may not participate in the obstacle course.

No access will be granted after any drug use and/or alcohol consumption.

Objects from outside the obstacle course are not permitted during use.

For safety reasons, we do not advise use of the inflatable obstacle course if you are pregnant.

Follow all safety guidelines provided by the on-duty attendant or staff.

Smoking on the inflatable obstacle course is not permitted.

Food and drink are not permitted during use.

Participants must remove watches, jewelry, keys, or other sharp objects before using the inflatable obstacle course.

Participants and guardians are responsible for using proper sun protection and monitoring time spent in the sun.

Use of a lifejacket or flotation device is required at all times during use.

**Neither H2O Entertainment nor Big Water Marina and Campground can be held responsible for any accidents that occur due to improper use of the inflatable obstacle course or by not following the safety rules above. The on-duty attendant may eject participants who endanger their safety or others.**
